

- No. 83. - An Act to further amend Chapter Fifty-six of the Revised Administrative Code, as amended by Republic Act Numbered Eighteen hundred thirty-six. (Re - salaries of provincial engineers.)
Introduced by Senator Mabanag and filed on Feb. 27, 1958;
Submitted to the Senate on Feb. 28, 1958;
Referred to the Com. on Finance on the same day;
Returned by said Com. with Com. Rept. No. 98, recommending that it be approved without amendment on May 2, 1958;
Submitted said Report to the Senate on the same day;
Passed on second reading by the Senate without amendment on May 14, 1958;
Printed copies distributed to the Senators on May 17, 1958;
Passed on third reading by the Senate on May 20, 1958;
The House having passed a Bill (H. No. 1316) similar to this Bill, and owing to discrepancies found in the provisions of the two measures, the Senate asked for a conference on May 20, 1958, having designated as representatives on its part Senators Rodrigo, Mabanag and Padilla;
The House insisted on its Bill and accepted the conference asked for by the Senate on May 20, 1958, having appointed as conferees at the same on its part Congressmen Peralta, Encinas and Nepomuceno;
Conference Report was submitted with the statement that the Conference Committee has reached an agreement on the disagreeing votes of both Houses, and agreed to by the Senate on May 21, 1958;
The House approved the Report of the Conference Committee on May 21, 1958;
Enrolled copies of the Bill were sent to the President of the Philippines for his action on June 10, 1958;
Approved by the President of the Philippines on June 13, 1958;
Converted into Republic Act No. 2054.
84. - An Act to add another paragraph to Article Two hundred and one of Act Numbered Three thousand eight hundred and fifteen, otherwise known as the Revised Penal Code.
Introduced by Senator Padilla and filed on Feb. 27, 1958;
Submitted to the Senate on Feb. 28, 1958;
Referred to the Com. on Codes and Constitutional Amendments on the same day;
Returned by said Com. with Com. Rept. No. 406, recommending that it be approved with amendments, on Feb. 4, 1959;
Submitted said Report to the Senate on Feb. 5, 1959;
(Pending in the Calendar.)
85. - An Act creating the Office of the Board of Trade to administer the allocation of foreign exchange for imports, and for other purposes.
Introduced by Senator Puyat and filed on Feb. 27, 1958;
Submitted to the Senate on Feb. 28, 1958;
Referred to the Com. on Commerce and Industry on the same day;
Returned by said Com. with Com. Rept. No. 15, recommending that it be consolidated with S. No. 31 and be approved as S. No. 90 on March 3, 1958;
Submitted said Report to the Senate on March 4, 1958;
(Substituted by S. No. 90.)
86. - An Act to restrict and regulate advertising devices adjacent to the national highway system.
Introduced by Senator Tañada and filed on Feb. 28, 1958;
Submitted to the Senate on March 4, 1958;
Referred to the Com. on Public Works and Communications on the same day;
