History awaits Heat-Raptors winner

Lanz Uy tops Faldo Series PH qualifier

Lanz Uv survived the spirited challenge of his rivals and ruled the ninth edition of the Faldo Series Philippines Championship at the Eagle Ridge Golf and Country Club Faldo course in Gen. Trias, Cavite.

Uy closed out with a 79 for a 240 total and beat Carlo Villaroman, Liam Cully and Diana Araneta for the top honors in the second leg of the record-breaking 2016-17 Faldo Series Asia campaign.

Uy was the only player in the field to break 80 twice in the 54-hole event that receives points for the R&A's World Amateur Golf Ranking.

Three shots off the pace being set by Araneta heading into the final round, Uy wiped out the deficit over the front nine, which he covered in one-over 37.

Thanks to hard-earned pars at No. 10 and No. 11, Uy then forged

Although Villaroman made up five shots on the leader over the final five holes to match Uy's 79, it was not



quite enough and he had to settle for second place behind Uy in both the Boys' Under-18 category and in the overall stand-

ings. Villaroman was left to rue two costly holes the short third where he ran up a triple-bogey six and the

Like Uy and Villaroman, Cully signed off with a 79 but was edged out of second place on a countback.

Araneta topped the leaderboard in the Girls' Under-21 section to win a place in the 11th Faldo Series Asia Grand Final, to be hosted by Sir Nick Faldo at Laguna Lang Co in Danang, Vietnam, in March, 2017.

Joining Araneta and Uy to fly the flag for the Philippines will be Perry Josef Bucay [Boys' Under-16 champion] and Laia Barro [Girls' Under-16 champion].

Supported by The R&A and endorsed by the Asian Tour and the Asia Pacific Golf Confederation, the 2016-17 Faldo Series Asia campaign stretches over 11 months.
