## Same old families still reign over lloilo politics

LOILO CITY — The results of the May 9, 2016 politics point to one thing – members of old political families here remain dominant over politics in the city and province of Iloilo.

For instance, Jerry Treñas was reelected Congressman representing Iloilo City's lone district. His nephew Jay, son of his late brother, Francis Treñas, was reelected city councilor while his brother-in-law, Jose Espinosa III was reelected Vice Mayor.

In Iloilo province, there are the Defensors led by reelected Governor Arthur Defensor Sr. His son, Iloilo Third District Rep. Arthur Defensor Jr. was also voted back to office while another son, Atty. Lorenz Defensor, was elected as provincial board member.

The Iloilo governor's nephew, Jason Gonzales, meanwhile, is mayorelect of Lambunao, replacing Defensor's brother-in-law, who was former mayor of that town.

Led by patriarch, former Rep. Oscar Garin, Sr., the Garin family continue to dominate politics in Iloilo province's First District. Rep. Garin is now mayor elect of the town of Guimbal while his wife, incumbent Iloilo Provincial Board Member Ninfa

Serag-Garin, is mayor-elect of the town of San Joaquin.

The Garins' daughter, incumbent Guimbal Mayor Christine Garin, won in the vice-gubernatorial contest in Iloilo, while her brother, Iloilo First District Rep. Richard Garin, who is also the husband of Health Secretary Janette Loreto-Garin, retained his seat. Votes for party list bets are yet being counted and if luck is on her side, yet another daughter, Sharon Garin, who ran as AAMBIS-OWA party list bet, could also find herself

Meanwhile, the Tupases in Iloilo's Fifth District, continues to hold clout over the area despite a bitter rivalry among members of the clan. Vice Governor Raul Tupas defeated his sisterin-law, Atty. Yvonne Angeli

Lee-Tupas, who is the wife of his older brother and incumbent Rep. Niel Tupas Jr., in the congressional race for the Fifth District.

Rep. Tupas himself lost in the vice gubernatorial contest. But reelected to their respective posts are Barotac Viejo Mayor Niel Tupas III and Iloilo Provincial Board Member Nielo Tupas.

Parly Balleza, husband of Niellette Tupas-Balleza, was also elected as Barotac Viejo vice mayor while Dr. Candice Tupas, wife of former Iloilo City Councilor Lex Tupas, was elected into the Iloilo City Council.

## Landslide win for Leonardia in City Hall battle

BACOLOD CITY, Negros Occidental — Representative Evelio Leonardia reclaims City Hall after a bitter electoral contest last May 9, 2016 for the Bacolod mayoralty against old foe, incumbent Mayor Monico Puentevella.

With 120,231 votes or a lead of

22,238 votes over Puentevella's 97,993 votes, Leonardia ended what many here in the city had billed as "The Final Battle" between him and Puentevella against whom he had been locked in a protracted political contest since 1988.

The votes cast for Leonardia in the last May 9, 2016 local elections gave him the biggest landslide victory in the history of Bacolod politics. Leonardia will now be going back to City Hall for an unprecedented fifth term as mayor of this city.

Both Leonardia and Puentevella started their political careers in 1988 when they both ran for the city council. Leonardia topped that election with Puentevella coming in

second. Three years later, they both ran for Bacolod City vice-mayor. Leonardia won.

The rivalry between the two men continued to be played out in media as both subsequently successfully ran for different political posts - Puentevella for Congress while Leonardia took City Hall. They encountered each other again in 2010 when Puentevella gunned for the mayoralty after his congressional stint. He was foiled by Leonardia in that contest.

In 2013, with Leonardia's term as mayor ending, Puentevella ran for that post and won. Leonardia, meanwhile, ran for and was voted to Congress.

In the last elections, Leonardia decided to give up his congressional seat and run for mayor against Puentevella, a contest in which the latter was trounced royally.

It was also a landside win for Leonardia's party, the Nationalist People's Coalition-Grupo Progreso (GP) with members clinching positions for congressman, vice mayor, and eight of the 12 city council seats.

Puentevella's Pamilya Magbinuligay Kita Kapamilya, meanwhile, only won four slots in the Sangguniang Panlungsod (City Council).

Incumbent Vice Mayor Greg Gasataya won as congressman, while El Cid Familiaran won as Bacolod City Vice Mayor.

## Sperm whale rescued in Antique

Coast guards rescued over the weekend a sperm whale which was stranded at the shoreline of a village in Antique.

"A disoriented sperm whale was beached at the shorelines of Barangay Marina, San Jose, Antique around 9:30 a.m. yesterday," the Philippine Coast Guard (PCG) stated in a report which was posted on its website yesterday. The sea mammal measures 546 centimeters in length, 76 centimeters in width and weighs 80 kilograms, according to the PCG.

The PCG reported that Ronald Charlie Ledesma, 24, found the distressed mammal 10 meters from the shoreline. He immediately reported the incident


