- Senate accepted the request of the House of Representatives for a conference, designating Senators Herrera, Tañada, Maceda, Romulo and Ople as its conferees;
- Apr. 27 - Conference Committee recommended that SBN-1240, in consolidation with HEN-4869 be approved;
- Sponsorship remarks of Senator Herrera;
