

#### BY THE PRESIDENT OF THE PHILIPPINES

#### PROCLAMATION NO. 952

DESIGNATING SEVERAL PARCELS OF LAND LOCATED IN BARANGAYS SAN FERNANDO, LUTA SUR AND SANTIAGO, MUNICIPALITY OF MALVAR, AND BARANGAYS SAN LUCAS AND PLARIDEL, LIPA CITY, BATANGAS PROVINCE FOR INCLUSION IN THE EXISTING LIMA TECHNOLOGY CENTER – SPECIAL ECONOMIC ZONE PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, otherwise known as the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, RODRIGO ROA DUTERTE, President of the Republic of the Philippines, do hereby designate several parcels of land, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations and PEZA Board of Directors Resolution Nos. 15-657 (s. 2015) and 16-328 (s. 2016), located in Barangays San Fernando, Luta Sur and Santiago, Municipality of Malvar and Barangays San Lucas and Plaridel, Lipa City, Batangas Province for inclusion in the existing Lima Technology Center – Special Economic Zone, with an aggregate area of Four Hundred Twelve Thousand Eight Hundred Twenty-Five Square Meters (412,825 m²), more or less, as defined by the following technical description:
