- Jul. 13 - House of Representatives requested the Senate for a conference on the disagreeing provisions of SBN-763 and HBN-7612, designating Representatives Funzalan, Jr., Teves, Salceda, Briones, Suarez, Sarmiento, Baterina, Defensor and Montemayor as its conferees (See: O.B. dated Aug. 5, 1999);
- 14 - Senate agreed to a conference, designating Senators Enrile, Magsaysay, Jr., Honasan, Flavier and Barbers as its conferees;
- 15 - Conference Committee Report submitted to the Senate recommending that HBN-7612, in consolidation with SBN-763, be approved as reconciled;

- Conference Committee Report approved by the Senate;

signed into law and became
REPUBLIC ACT NO. 8752.
