SECTION 1. There shall be established a regular district office of the Land Transportation Office (LTO) in the Municipality of Alicia, Province of Isabela.

SECTION 1. There shall be established, under the supervision of the Land Transportation Franchising and Regulatory Board (LTFRB), a regular district office of the LTFRB in the City of Bacoor, Province of Cavite.

SECTION 1. There is hereby established a regular district office of the Land Transportation Office (LTO) to be located in the Municipality of Alcoy in the Second District of Cebu.

SECTION 1. There shall be established, under the supervision of the Department of Transportation, a regular LTO District Office in the Municipality of Ibajay in the Second District of Aklan to be known as the "Western Aklan Land Transportation Office (LTO) Center."

SEC. 2. The Secretary of Transportation shall immediately include in the Department's program the operationalization of the LTO-Alicia District Office in the Province of Isabela, the funding of which shall be included in the annual General Appropriations Act.

SEC. 2. The Secretary of Transportation shall immediately include in the Department's program the operationalization of the LTFRB Regular District Office in the City of Bacoor, Province of Cavite, the funding of which shall be included in the annual General Appropriations Act.

SEC. 2. The Secretary of the Department of Transportation shall immediately include in the Department's program the operationalization of the LTO district office in the Municipality of Alcoy, Province of Cebu, the funding of which shall be included in the annual General Appropriations Act.

SEC. 2. The Secretary of Transportation shall issue the rules and regulations necessary to carry out the purpose of this Act.

SEC. 3. This Act shall take effect fifteen (15) days after its publication in two (2) newspapers of general circulation.
