the very first bill called to the floor for discussion.

Mr. President, I believe that of all bills so far in this present Congress, this bill has been given the longest period by us for its consideration and now its ultimate approval.

As the gentleman from Negros Oriental said, although he was one of the fathers of this bill, ncw he cannot recognize this bill. At least, if he has planted a seed, if he is the father, he has his blood there, although he can no longer recognize the features. (Laughter.)

Mr. President, I am well aware of the seriousness of the objection to the portion of this bill which is commonly called the Tolentino-Aytona-Pelaez-etcetera Amendment because, although in this case I would not say I am the father of the idea, at least I planted the seed, but the tree has grown to such proportions that I did not expect it would be this way.

However, I am happy because the idea of a direct sale to the tenant or lessee is something that has been very thoroughly discussed. There was this thorough discussion, because it was something that was new and perhaps, which even I myself did not expect would come up in the course of this legislation. Perhaps, if we had not presented this amendment on direct sale, this bill would have been approved long ago. It was this portion of the bill that proved to be most controversial and therefore merited the longest period of discussion.

But, as I said, although I am aware of the serious constitutional objections that have been raised, considering the laudable objective, I have been willing to take the risk of the constitutionality being questioned to attain the objective that we have set.

Now, Mr. President, before I close, it would be most fitting to call and focus attention to the great job that has been done by the sponsors of this measure. Senators Laurel and Pelaez were on this floor for many days and many hours exhausting their energies and their patience such that at times, we had to ask for suspension so that tempers may cool down.

I would like to thank them for having ably two steered this bill through. I would like to thank Hou the distinguished gentleman from Batangas, Senator Diokno, for his very good contribution to this bill. I would like to thank the distinguished Con gentleman from Quezon, Senator Tañada, for Con his valuable suggestions which the sponsors have incorporated into this bill. Although he may not agree with certain aspects of the bill, his contributions are in the bill and they have improved this measure a great deal.

I would like to thank also the members of the Senate for all the contributions, the discussions, the suggestions that they have made to make this bill as it is now. I only hope that when this bill goes down to the House of Representatives, it will be taken in the same spirit that the Senate has taken it. It is in this hope that we close the discussions and consideration of this bill, the first bill in the regular session, the last bill in this special session.

I vote in favor of this bill, Mr. President.

The following is the text of the Conference Committee on House Bill No. 3044:

#### CONFERENCE REPORT

The Committee on Conference on the disagreeing votes of the two Houses on the amendment of the Senate to House Bill No. 3044 entitled:

"AN ACT ESTABLISHING A NATIONAL POLICY ON POPULATION, CREATING THE COMMISSION ON POPULATION AND FOR OTHER PURPOSES."

having met, after full and free conference have agreed to recommend and do recommend to their respective Houses as follows:

THAT HOUSE BILL NO. 3044 AS PASSED BY THE HOUSE BE ADOPTED WITH THE FOLLOWING AMENDMENTS:

- 1. On page 1, lines 5-10, after the word "development" and comma (,), in line 5, delete all the words to the word "growth" in line 10 and in lieu thereof, substitute the following words: "INCREASING THE SHARE OF EACH FILIPINOS IN THE FRUITS OF ECONOMIC PROGRESS AND MEETING THE GRAVE SOCIAL AND ECONOMIC CHALLENGE OF A HIGH RATE OF POPULATION GROWTH, A NATIONAL PROGRAM OF FAMILY PLANNING WHICH RESPECTS THE RELIGIOUS BELIEFS OF THE INDIVIDUALS INVOLVED SHALL BE UNDERTAKEN."
- E2. On page 2, line 22, after the word "welfare" and "comma", insert the following words: "THE COMMISSIONER OF NATIONAL INTEGRATION, THE PRESIDENTIAL ARM ON COMMUNITY DE-

VELOPENT,".

- 3. On page 3, line 1, between the words "the" and "Philippines", insert the word "FOLLOWING" and "COLON" (:).
- 4 On page 3, line 3, after the word "Association" and between the "comma" and the word "Family", delete the word "and".
- 5. On page 3, line 4, after the word "Philippines", place a "COMMA" and add the words "THE RES-PONSIBLE PARENTHOOD COUNCIL": and immediately following on the same line, delete the entire phrase from the word "and" up to the word "Clubs", in line 5 and in lieu thereof, insert the words "AND THE INSTITUTE OF MATERNAL AND CHILD HEALTH."
