

EXPLANATORY NOTE

Our elder citizens deserve more recognition than what they are presently getting. This is specially true for those who have spent the best and most productive years of their lives in the service of their country and their fellow citizens. It cannot be denied that in their own way, no matter how quiet and small, they have contributed in the common effort to make this country a better place to live in. Now, in the waning years of their lives, they should be provided ample opportunity to experience the fruits of their labor for the remainder of their years. By so providing, we who have been beneficiaries of the toils of our elders, will only be showing our gratitude for their unselfish and dedicated service.

Perhaps because of the present difficulties we are facing, most, if not all of us, have overlooked or given scant importance to this large segment of our population. It's about time we acknowledge the efforts of our elder citizens. We who may be in a better position to render such recognition and gratitude should do so in our own way. Indeed, what better way can we have to uphold tradition of giving due respect for our elders.

Admittedly, our senior citizens in their present state could no longer sufficiently provide for their own livelihood and in most cases be dependent only on their meager presides and pensions and infrequent doleouts from relatives. By extending to them these privileges, specially during these trying times, we would be giving better meaning to and more profound implementation of the social justice provision of our constitution.

For these considerations, early approval of this bill is earnestly requested.

GRANTING DISCOUNT PRIVILEGES TO SENIOR CITIZENS AND FOR
OTHER PURPOSES.

Be it enacted by the Senate in session assembled:

- SECTION 1. The following establishments operating and doing business in the Philippines shall grant a privilege discount to any filipino citizen as follows:
 - a. Transportation companies 30% of the total travel fares charged for travelling anywhere in the Philippines;
 - b. Restaurants and Eateries, beer joints, cocktail lounges and similar establishments - 30% of the total value of food and drinks orderes;
 - c. Hotels, Pension Houses, Lodging House and Inns 30% of the value of room rent and meals;
 - d. Moviehouses, theaters and similar places of entertainment 30% of the total admission fee charges. The privilege discount above enumerated shall apply only to the personal bill of the senior citizen.
- SEC. 2. For purpose of this Act, a senior citizen shall refer to a filipino citizen actually residing in the Philippines and at least 60 years of age at the time he avails of the privilege.
- SEC. 3. Any establishment covered by this Act that refuses to grant the privilege discount herein enumerated shall be liable to cancellation of its permit or license.



SEC. 4. The Secretary of Social Services and Development is hereby authorized to enforce this Act and to promulgate the pertinent rules and regulations for its proper implementation.

EXPLANATORY NOTE

Special benefits and privileges should be given to our elder citizens to enhance their well-being throughout their remaining years. It cannot be denied that during the productive years of their lives our Filipino elders have contributed in the common effort to make this country a better place to live in, no matter how simple and quite.

Having been the direct recipients of our elder's productive years, it is but fitting that we take steps to extend them a more meaningful existence. We must afford them concessions most needed in their years of difficulty caused by sickness, limited mobility, low finances and such other handicaps.

With the present difficulties that the nation is encountering, most, if not all, of us have overlooked or given scant importance to these roots of our lives. But as the saying states " Ang taong hindi marunong lumingon sa pinanggalingan ay hindi makakarating sa paroroonan " it is but imperative upon us who are in a better position to render such recognition to do so in our own way.

This bill will extend to the elderly accommodation without further appropriations necessary to dignify their existence and strengthen their part in the society as they truly deserve.

Considering the foregoing, early approval is earnestly requested.

GRANTING DISCOUNT PRIVILEGES TO FILIPINO ELDERS AND FOR OTHER PURPOSES.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
