Senate reconstituted its conferees designating Senators Angara, Alvarez, Shahani and Guingona, Jr. as members of the conference committee on February 3, 1992;

House of Representatives agreed to the request of the Senate for a conference designating Congressmen Padilla, Montelino, Escudero III. and Puey as its conferees on February 3, 1992;

Conference Committee recommended that S. B. No. 1492 and H. B. No. 35379 be consolidated and approved;

Sponsorship remarks by Senator Angara on February 5, 1992;
