

RESOLUTION EXPRESSING THE SENSE OF THE SENATE THAT THE DEPARTMENT OF BUDGET AND MANAGEMENT SHOULD USE THE MISCELLANEOUS PERSONNEL BENEFITS FUND FOR THE IMMEDIATE RELEASE OF THE FOURTH TRANCHE OF THE SALARY STANDARDIZATION LAW AS PROVIDED UNDER EXECUTIVE ORDER 201, SERIES 2016

- 1 WHEREAS, last 19 February 2016, Executive Order (EO) 201 was signed 2 modifying the salary schedule of civilian government personnel and authorizing the grant of additional benefits for both civilian and uniformed personnel to ensure the 3 payment of just and equitable compensation to all government employees; 4
- 5 WHEREAS, EO 201 authorizes the Department of Budget and Management (DBM) to implement the salary increases under the modified salary schedule in four 6 7 tranches up to 2019;
- 8 WHEREAS, the General Appropriations Act (GAA) of 2018 provided for a 9 Miscellaneous Personnel Benefits Fund (MPBF) in the amount of P99.446 billion. Of the P99.446 billion in the MPBF, P62.8 billion is for Compensation Adjustment, while 10 11 P12.36 billion is for Staffing Modification Upgrading of Salaries:

WHEREAS,	the	MPBF	is	used	to	fund	Personnel	Services	deficiencies	of
employees who are	still	in gove	erni	ment s	serv	vice ex	cept those	pertaining	g to filling-up	of
existing and newly created positions provided under agencies' budgets;										

WHEREAS, with the re-enactment of the GAA 2018, the DBM may use the MPBF provided to fund the fourth and final tranche of the Salary Standardization Law (SSL) under EO 201 s. 2016, which increases the salaries of government employees;

WHEREAS, the DBM is authorized to release and pay the salaries immediately, without the need for further approval from Congress. Accordingly, the DBM should process and release the fourth tranch of SSL since there is no legal impediment to implement the increase in the salary of government employees;

WHEREAS, in 2016 during the initial implementation of the SSL, the MPBF was already tapped for a similar purpose and was used to fund any deficiency as a result of the salary adjustments.

WHEREAS, there is absolutely no reason for DBM not to immediately disburse the funds needed for the salary increases, which can help government personnel in dealing with the prevailing high prices of basic commodities and services. As government employees, they are entitled to timely receive the corresponding compensation for the job done as this is their fundamental right;

RESOLVED, AS IT IS HEREBY RESOLVED, to express the sense of the Senate that the DBM should use the MPBF under the 2018 GAA for the immediate release of the fourth tranche of the SSL, as provided under Executive Order No. 210 s. 2016.
