At 12:32 A.M., the Presiding Officer of the Technical Working Group of the Committee on National Defense, Ms. Daisy Parker, opened the meeting.

MR. ALEJANDRO. Coast Guard - Proposing for the inclusion of the Coast Guard to the Department. Kaya lang bago ang pangalan, ano? Parehas lang naman.

THE PRESIDING OFFICER. So far, wala dito iyong bill of civil defense, and then iyong Public Safety College ipapasok namin bale dito.

MR. ALEJANDRO. May draft na ba sa Civil Defense Office?

THE PRESIDING OFFICER. Iyon na nga, e, ginagawa namin. Meron kasing mga bills na nasali sa amin.

MR. ALEJANDRO. Tungkol doon.

MS. OLAÑO. Meron na ho dito.

THE PRESIDING OFFICER. On civil defense?

MS. OLAÑO. Oo.

MR. ALEJANDRO. Actually meron ano iyan, e, meron sa present set up.

MS. OLAÑO. Ako, I remember, I drafted. I don't know ...

THE PRESIDING OFFICER. Pero, di ba ang Civil Defense meron iyang talagang military aspect. Dito siguro what we can get is, iyong civil aspect noong ano, iyong police function.

MR. ALEJANDRO. Kaya nga, under the present set-up, under kasi ng DND iyan, one of the bureaus under DND. Pero sa tingin ko, nag-file si Amel niyan, e. iyan si Ziga.

MR. ORA-A. Hindi, kung maipasok sa bagong department, mawawala iyong ...

THE PRESIDING OFFICER. Kasi, ito o, itong civil assistance, pero iyong civil defense, sa ano talaga iyan, sa DND. Same police councils kukunin natin.

MR. ORA-A. A, ganoon ba?

THE PRESIDING OFFICER. Oo.

MR. ORA-A. A, iyong police functions lang ng civil defense.

THE PRESIDING OFFICER. Specifically, iyong sa disaster control, di ba, disaster - sino ang papasok sa atin.

MR. ORA-A. Sana we get from the ano, e..Me ifini|e si Ziga doon, e.

MS. OLANO. Meron din ako dito...

THE PRESIDING OFFICER. Itong national disaster....

MS. OLANO. i-separate from the DND na.

THE PRESIDING OFFICER. Ito ang functions bale ng Office of Civil Defense.

Puede nang mahiram?

MS. OLANO. Ito na, if we filed it. Pero, makapal iyon. Parang nakikita ko nang magkre-create ng separate office of Civil Defense, separate from the DND.

MR. ALEJANDRO. itong national preparedness...

THE PRESIDING OFFICER. Philippine Disaster Preparedness and Preventive, ...

So, iyon ang medyo hindi namin na-tackle. May functions, at saka nag-request ang Office of Civil

Defense if they can present a position paper, kasi di ba na-include sila? Wala naman iyan sa Senate and House version.

So, ang ano namin huwag munang - we can touch it siguro. I-polish muna natin iyong ibang provision tungkol dito.

MR. ALEJANDRO. Oo. Papalitan.

THE PRESIDING OFFICER. Kasi, ... O, sige, mag-lunch muna tayo.

At 12:32, P.M. the meeting was resumed.

THE PRESIDING OFFICER. Bureau. Magiging bureau na bale. Land bureau under the ...

Iyong Philippine Public Safety College walang problema, dahil kunin lang natin ang provisions ninyo.

MR. ALEJANDRO. Sa ano, sa Senate?

THE PRESIDING OFFICER. Sa Senate.

MR. ALEJANDRO. Okay na lang ho iyon, doon sa provisions na iyon, okay na.

THE PRESIDING OFFICER. Except that merong mga provisions sa amin na puedeng...

Pero, ang gusto kong i-clarify kasi ang position ng INP, although we're going to create a Philippine Public Safety College, huwag rin daw i-abolish iyong PNPA.

MR. ALEJANDRO. Nasa kanila naman iyon, e.

THE PRESIDING OFFICER. Hindi, i-specify na.

MS. OLANO. ... E, di dala-dalawa.

THE PRESIDING OFFICER. Well, iyong parang ano.

Iyong PMA, di ba ngayon, and then merong National College, di ba? Oo, National Defense College.

MR. ALEJANDRO. May ibang purpose noong National Defense College.

THE PRESIDING OFFICER. Hindi. Iyon na nga training, at the same time, pero ang...

MR. ALEJANDRO. Basic course talaga iyong PMA compared to the National Defense College, karamihan doon mga masteral.

MR. ORA-AN. masteral iyan, e.

THE PRESIDING OFFICER. Kaya nga, doon din ang

...

MS. OLANO. Ano bang magiging thrust nilang dalawa? Bakit ise-separate pa.

THE PRESIDING OFFICER. Kasi iyong isa talaga, specifically under the PNP, training, iyong PNPA.

MS. OLANO. And the other one.

THE PRESIDING OFFICER. Iyong isa mga masteral courses.

MR. ALEJANDRO. Ayon.

THE PRESIDING OFFICER. Iyong Philippine Public Safety College.

MR. ALEJANDRO. Not necessarily masteral, kasi two different ano naman iyon, e.

MR. ORA-A. Kasi, kahit iyong police puede namang makapasok ng National Defense College, e. Sa lahat naman iyon, e.

THE PRESIDING OFFICER. Oo.

MR. ORA-A. So, why do we have two, the same kind of and

THE PRESIDING OFFICER. Kasi, may training component dito sa PNPA.

MR. ORA-A. I-transfer na lang kaya sa ano, sa National Police Academy/

MR. ALEJANDRO. Ang PNPA kasi basic training ng police courses.

THE PRESIDING OFFICER. Oo.

MR. ALEJANDRO. Saka iyong ibang mga technical courses, like radio communications.

Ngayon, pagdating sa Public Safety College, this concerns the non-police aspect training. Let's say kanilang preparedness na iyan. Iyong mga

red cross related courses doon sa Public Safety College. Iyon ang ibig sabihin ni Daisy.

THE PRESIDING OFFICER. At the same time, may training ano pa, may center.

MR. ALEJANDRO. Okay iyon.

THE PRESIDING OFFICER. Separate from the PNPA.

MS. OLANO. Before anything else, let's introduce ourselves. Iyon nga we work together without knowing each other.

(break)

THE PRESIDING OFFICER. This NAPOLCOM is the administrative arm. We're talking now of the operation, being operation branches. Ihiwalay iyong Jail and Fire. Hindi nga iyong under ng PNP, gagawin na lang nating bureaus iyon, plus the Office of the Civil Defense and the Philippine Public Safety College.

So we have five line bureaus, isang staff bureau, the NAPOLCOM. Kaya lang, hindi nila na-foresee...

MS. OLANO. Sandali, papano nangyari sa NAPOLCOM, kasi ang NAPOLCOM dapat independent body iyan, e.

Iyong nga precisely.

THE PRESIDING OFFICER. Hindi, independent pa rin.

MR. ALEJANDRO. Kaya lang, under the department.

THE PRESIDING OFFICER. Collegial body iyong NAPOLCOM, BUT THE Chairman of the NAPOLCOM will be the Secretary.

So, iyong Secretary is the concurrent Chairman of the NAPOLCOM.

MR. ALEJANDRO. What do you mean by that version diyan, because under the ^{Senate version} Napolcom is a separate,

distinct and independent body iyan.

THE PRESIDING OFFICER. Precisely, precisely.

MS. OLANO. Actually, iyon ang ano ko doon, what will happen now.

MR. ALEJANDRO. ang question diyan. Tingnan mo iyang under the Constitution.

THE PRESIDING OFFICER. Iyong sa 16, Article XVI.

MR. ORA-A. ^{Specified} ~~specified~~ ba doon na ano, NAPOLCOM kailangan?

THE PRESIDING OFFICER. Oo.

MR. ALEJANDRO. Independent commission iyon, e.

THE PRESIDING OFFICER. Hindi naman. Pero nakalagay doon, talaga....

MR. ORA-A. Even if it is an independent commission.... direct ba sa President iyan, o....

MR. ALEJANDRO. Direct sa President, supposed to be.

MS. OLANO. Siyempre. Dapat kasi considering na President talaga ang ano...

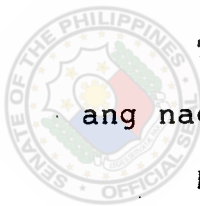
THE PRESIDING OFFICER. Pero, ang Senate kasi ang nagba-back to the department type of ..

MR. ALEJANDRO. Kung nandoon ang Department of Interior. Liniitan nga.

MR. ORA-A. Kaya ang Bureau of Interior ginawang... lumiit, e.

MR. ALEJANDRO. Ginawang Department of Public Safety na lang.

THE PRESIDING OFFICER. Oo.



MR. ALEJANDRO. Lumiit iyan ng scope, because it's the Interior...

THE PRESIDING OFFICER. Pareho lang.

MR. ALEJANDRO. Hindi. If it is the Interior, sakop ang Local Government, e, at least of the revenue machinery.

MS. OLANO. When the commission provides for this, it ...I don't know....

THE PRESIDING OFFICER. It had in mind. Meron, meron.

MS OLANO. It should be independent in character. Kasi, if we would place it under a department, ...

MR. ORA-A. Civil Service Commission, ano ba ang atin?

MR. ALEJANDRO. Hindi. Under na nga iyan, e. Independent commission iyan, e.

MS. OLANO. Oo, iba iyon. Iba talaga iyon.

MR. ALEJANDRO. Auditing.

MS. OLANO. Actually, hindi puede namang i-categorize those ano. Pero, considering now...

MR. ALEJANDRO. Pero, wala naman sigurong restriction diyan na...

THE PRESIDING OFFICER. Iyon na nga e.

MS. OLANO. Wala naman actually.

THE PRESIDING OFFICER. Iyong. Actually that can be used as an argument.

MS. OLANO. Oo. Kaya lang, mayroon ba tayong deliberations sa ConCom?

MR. ALEJANDRO. Dapat iyong intent ng ano malaman. Kasi, even if it is a commission, independent, but it can still be under a department, kung wala namang restrictions.

MS. OLANO. That's right.

Wala na bang ano? Ano pa bang pertinent provisions?

THE PRESIDING OFFICER. Kasi, ito iyong deliberations sa Congress, iyong PNP. Hanggang wala namang nabanggit diyan, they cannot create a department. Silent iyong ano. Pero, ang na-envisioned talaga nila, a PNP under the administration and control of a National Police Commission.

MR. ALEJANDRO. Oo. Very clear iyang...

Pero, sa Senate, resolved iyan, because the deliberation of Senate, ina-under ng BOI, Department of Interior, but which is equal in level with the PNP. Ang na-provide lang doon ang na-approve lang maski administrative functions or ...

THE PRESIDING OFFICER. Actually naman equal in... Ang ano lang...

MR. ALEJANDRO. Kaya nga, sa ilalim ang bureau.

THE PRESIDING OFFICER. Hindi. Ganoon din sa inyo, e. Ganoon din sa inyo. Same set up. Pareho lang ang House and Senate on that, except that mas malaki ang scope ng Senate version.

MS. OLANO. Ito lang ang ano, e, NAPOLCOM or whatever.

MR. ORA-A or department under ...

MR. ALEJANDRO. President pa rin. Ang gusto kasi nila noon, directly under the Office of the President, katulad ng present set up.

MS. OLANO. Parang awkward talaga.

So, ano na ngayon ang set up?

THE PRESIDING OFFICER. Ang set up, ito department, Office of the Secretary.

MR. ORA-A. Kasi, if we liken that to other commissions, like CID.

MR. ALEJANDRO. Wala nang bureau diyan. Commission Immigration because of the connotation of commission, because CID is under the Department of Justice, so they changed it to Bureau of Immigration, under...

MS. OLANO. Iyon ho na ba?

MR. ALEJANDRO. Meron. Specific order lang naman.

Ms. Olanó, nabasa ninyo na ba?

MS. OLANO. Oo nga, iyon na nga, e.

MR. ALEJANDRO. When the constitution was formulated, baka ang gamit / commission in the sense not like the Constitutional Commission.

MR. ORA-A. Marami kasing commission pa, e, na which are also under departments.

MR. ALEJANDRO. Pero, ang intent talaga ng ano doon, e, to be placed / under the / according to the constitutional commission's procedure.

MS. OLANO. Oo, control and supervision.

MR. ALEJANDRO. Control and supervision. Yes. In fact, the National Prosecution is in the Office of the President, is under the Office of the President, Your HONOR. Malinaw.

THE PRESIDING OFFICER. Still under the department iyan. Di, sa executive pa rin iyan.

MR. ALEJANDRO. That's, Your Honor, that's the main reason...

THE PRESIDING OFFICER. Tapos, noong mag-meeting tayo, ang argument ni Yap, ministerial lang ang function noong Office of the Secretary, except that since concurrently Chairman siya ng NAPOLCOM, doon at least nawawala daw iyong any constitutional...

MR. ALEJANDRO. A, Chairman siya ng...

THE PRESIDING OFFICER. Oo, ng NAPOLCOM, noon.

MR. ALEJANDRO. That solves the problem.

THE PRESIDING OFFICER. Precisely, kaya ginawa nilang concurrent chairman. of the NAPOLCOM.

So, siya iyong ano siya appointed by the President, ang term niya upon the pleasure of the President. Pero iyong iba, iyong commissioners may specific term.

MR. ALEJANDRO. Ang iniwasan kasi nila diyan, e, making the department head as a very powerful ... corollary to the head of the DND. E-enforce din sa kanila, mayang mga iyan, e. Kung ganoon tala^{ga} ang gusto nila, alisin iyong Napolcom which controls this city police, under a single person.

THE PRESIDING OFFICER. Kaya nga ang undersecretary niya, dalawa lang. One for admin, and one for operation, to oversee the whole department.

MR. ALEJANDRO. And bureaus.

THE PRESIDING OFFICER. Oo. Tapos, isang iyong Napolcom staff bureau, tapos limang line bureaus. Under noon, iyong mga regional.

MS. FERNANDEZ. Pero, iyong sa lima na line bureaus, idinagdag ni Tamano iyong kuwan, iyan ang interes ni Senator Maceda. Iyong paper's output ng ... People's Arm for Community Development. Papano iyon?

THE PRESIDING OFFICER. People's Arm for Community Development. Hindi pa po iyon ni-resolve.

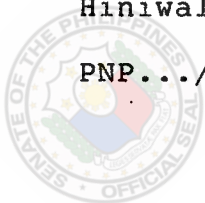
MS. FERNANDEZ. That will be brought to the mother committee.

THE PRESIDING OFFICER. Brought to the mother committee. So, hindi pa po resolved iyong point na iyon. And then, pati iyong sub-bureau of Coast Guard, amenable ang Senate na hindi na i-include.

So, as of now po, ang agreement five line bureaus and then one staff bureau in the Napolcom.

Kaya lang, mayroon hindi medyo malinaw, e. Hiniwalay nila iyong Fire and Jail Service from the

PNP.../lr



THE PRESIDING OFFICER. ... from the PNP. Ngayon kasi ang gusto nila, iyong PNP mainly police iyon which will be under the administration and control of the NAPOLCOM. Paano ngayon itong fire and the jail? Are we going to create separate...

MS. FERNANDEZ. (Legcomsec) Separate bureau.

THE PRESIDING OFFICER. Hindi, separate bureau. Eh ano ang admin branch niyan? Kasi dati...

MR. ORA-A. ... department.

THE PRESIDING OFFICER. Before kasi, ang admin branch niyan...

MS. OLAÑO. Ang sabi nga ni Congressman Gutang, parang bigyan ng ano, control ba, iyong local executives over those areas, doon sa fire and...

THE PRESIDING OFFICER. Lalabas na iyon sa common provisions natin sa latter part. Wala naman tayong problema diyan. Ang worry ko lang, kasi before, ang admin arm ng fire and jail is the NAPOLCOM dahil under sila ng PNP eh.

MR. ORA-A. So, under the present set up, it could be directly under the secretary, ganoon ang mangyayari.

MS. FERNANDEZ. Magiging the same level na iyon eh, iyong PNP at saka iyong...

MR. ORA-A. Pare-pareho silang bureaus eh.

MS. FERNANDEZ. Pare-pareho naman 'yan.

THE PRESIDING OFFICER. So ang may ano lang, admin arm, is the PNP.

MR. ORA-A. In effect, under the admin ganoon ang mangyayari. Iyon yata ang gusto nilang palabasin eh.

MR. ALEJANDRO. Maraming problemang magka-crop-up diyan kasi the functions of fire service at saka jail,

partly it's a police function.

THE PRESIDING OFFICER. Iyon na nga precisely.

MR. ALEJANDRO. And they would have...

THE PRESIDING OFFICER. Kaya nga eh.

MR. ALEJANDRO. How about the training, how about the disciplinary action?

MR. ORA-A. Hindi, ang may ... ano kasi, jail. Pero iyon, sa fire siguro wala.

THE PRESIDING OFFICER. Meron din.

MR. ALEJANDRO. Kasi pagpunta mo sa sunog,...

MS. OLANO. Hindi puwedeng wala.

MR. ALEJANDRO. ... puwedeng walang baril iyon.

THE PRESIDING OFFICER. So dapat talaga iyong may admin arm, iyong disciplinary ano kasi.

MR. ALEJANDRO. Iyon ang magiging problema diyan.

THE PRESIDING OFFICER. Hindi iyon ang clarified for...

MR. ORA-A. We can make that as a sub-footnote siguro. Kasi hindi naman natin puwedeng palitan iyong agreement nila eh.

THE PRESIDING OFFICER. Kasi iyong mga bills na pumapasok sa amin creating a separate fire protection service, bureau ho bale. Meron rin silang admin arm even in the nature of a National Fire Commission.

MR. ALEJANDRO. Katulad din ng NAPOLCOM.

THE PRESIDING OFFICER. Oo. Pero masyadong... pero magiging tedious ng masyado. Imagine, tatlo ang commission natin. Or otherwise, we can adopt the same setup before.

MR. ALEJANDRO. Under the ano pa rin.

THE PRESIDING OFFICER. Under pa rin ng NAPOLCOM.

MR. ALEJANDRO. And then merong mga sub-offices doon sa NAPOLCOM with respect to the jail and fire services. Ganoon din, iyong present setup.

THE PRESIDING OFFICER. Eh di iyong NAPOLCOM iyong chairman, 'no, tapos merong commissioners tapos tatlong...

MR. ALEJANDRO. Tatlo ring offices doon sa Commission.

MS. OLANO. Sandali, parang lumalaki na iyong bureaucracy.

THE PRESIDING OFFICER. Mas malaki kung gagawa tayo ng separate Commission.

MS. OLAÑO. Ang dami-dami.

THE PRESIDING OFFICER. Or i-expand, i-retain natin iyong NAPOLCOM pero... Kasi ang connotation nila, iyong National Police Commission mainly for PNP, kasi police, eh. Siguro we can change the nomenclature.

MS. OLAÑO. Pero ang ano kasi, under the present setup police includes ano eh, jail, firemen... etc.

THE PRESIDING OFFICER. Pero nga, iyong gagawin natin, i-separate natin iyong police from the jail and fire bureaus. Whereas, kung under sila ng NAPOLCOM, kasi meron na tayong common provisions in terms of iyong... iyong ranks, pare-pareho kasi eh, under sila ng NAPOLCOM. Iyong bill ninyo at saka bill namin eh dahil pareho more or less doon.

MR. ALEJANDRO. You know, personally I don't think na maganda... interrelated kasi ang trabaho ng pulis ngayon eh.

MS. OLAÑO. Oo. Dapat nga coordination in fact.

MR. BELEN. Related iyong dalawang iyon eh.

MS. OLAÑO. Dapat may coordination.

MR. ALEJANDRO. Actual situation, may sunog, kailangan magkaroon ng security diyan to cordon the area. Tawagin mo iyong commander ng pulis eh kung magkaaway iyong fire service chief at saka iyong chief of police doon...

THE PRESIDING OFFICER. Eh since pareho na silang bureau eh di...

MR. ALEJANDRO. ... pulis diyan, nandiyan ang mga looters, nandiyan lahat. Sa ngayon, 'pag sinabing chief of police, "O, sunog, o, Major, pumunta ka doon; Captain, pumunta ka doon." Nakikita nila iyong actual... ang problemang ganyan...

THE PRESIDING OFFICER. Ang mas feasible siguro...

MR. ORA-A. Hindi, ang problema naman kasi... On the other hand, if you look on the other point of view, mas maganda iyong... kasi everybody is responsible for its own job, hindi ba?

THE PRESIDING OFFICER. No, under our ano eh, iyong Senate and the House versions, separate naman sila eh - three service branches - except that under lahat sila sa NAPOLCOM. Ang mangyayari ngayon, ginawang bureau, hiniwalay din sila, wala na rin. Ang PNP lang ang mapupunta sa NAPOLCOM. Or suggest na the National Police Commission... I-define natin kung ano iyong National Police Commission - shall include, shall be the staff bureau of the administrative arm of the PNP, the fire bureau and the jail bureau. Puwede nating i-provide na ganoon, magbigay tayo ng definition para huwag nilang isipin na since police, National Police Commission, for PNP lang 'yon, 'no, although gagawin nating bureaus pa rin except that iyong tatlo... kasi wala tayong... Iyong Office of Civil Defense is... It's another bureau.

MR. ALEJANDRO. Sabagay under the present setup ang Office of Civil Defense ano eh...

THE PRESIDING OFFICER. Iyon na nga ang proposal, di ba?

MS. OLAÑO. Oo, kasi nga ang hirap-hirap daw ng...

THE PRESIDING OFFICER. Pareho ng gagawin nating...

kung ano iyong setup ng...

MR. ORA-A. Practically parang planning officer ito eh.

MR. ALEJANDRO. 'Pag kumilos ang OCD lahat kilos eh. ... coordinating office iyan - nandiyan ang DSW, nandiyan ang Education, nandiyan ang DND.

THE PRESIDING OFFICER. Kukunin natin iyong sa disaster ano nila, disaster control...

I-retain na lang natin iyong dating setup under Civil Defense(?)-- although bureau siya, separate bureaus iyong dalawa, still under sila ng NAPOLCOM. Tapos i-define natin ang NAPOLCOM.

MR. ALEJANDRO. Ganoon iyon, kasi importante iyon because of the staffing...

THE PRESIDING OFFICER. Oo. Saka iyong disciplinary ano...

MR. ALEJANDRO. All about personnel administration.

THE PRESIDING OFFICER. Ang operations walang problema eh.

MR. ALEJANDRO. Kanya-kanya iyan.

THE PRESIDING OFFICER. Administrative ang magiging problema.

MR. ALEJANDRO. Saka ano 'yan, meron ding provision diyan na... doon sa authority ng local government...

THE PRESIDING OFFICER. ... iyong resolve. So bale ang may addition ko, ang Chapter I, una, di iyong title, tapos iyong second iyong Declaration of Policy. Ang third natin, Chapter I, we'll focus on the Creation and Organization of the Department. Tapos Chapter II natin is the NAPOLCOM, Chapter III, PNP; Chapter IV iyong sa Fire; tapos iyong Jail.

Teka, kung
MS. OLAÑO. / department... teka, depende na kung sa
NAPOLCOM mo ilalagay iyong fire, etc.

THE PRESIDING OFFICER. Pero hiwa-hiwalay na chapters
bale sila para malinaw. Parang ganito. Ito iyong previous
ano natin eh. Ganito iyong setup. Ito iyong sa House, ito
iyong sa Senate. Sa House kasi: NAPOLCOM, tapos PNP,
tapos ito o. ... professionalism, disciplinary, local
officials, transitory... transition period.

MS. OLAÑO. So ano ang magiging arrangement?

THE PRESIDING OFFICER. Ipapasok ito ngayon, itong
"Creation of and Organization of the Department."

MS. OLAÑO. Oo.

THE PRESIDING OFFICER. Magiging Chapter I iyon, ito
Chapter II, ito III. Pagkatapos ito ngayon ang ano. Ito
