AN ACT CREATING AN ADDITIONAL LEGISLATIVE DISTRICT IN
CEBU CITY TO BE KNOWN AS THE THIRD (3RD) LEGISLATIVE
DISTRICT OF CEBU CITY AND FOR OTHER PURPOSES

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There is hereby created an additional legislative district in
2 Cebu City to be known as the Third (3rd) Legislative District by reapportioning
3 the current Second (2nd) Legislative District to commence in the next national
4 election after the effectivity of this Act. Henceforth, the following barangays
5 shall comprise the Third (3rd) Legislative District, to wit:

- 6 (a) Kalunasan;
7 (b) Sapangdaku;
8 (c) Buhisan;
9 (d) Toong;
10 (e) Sudlon I;
11 (f) Sudlon II;

- 1 (g) Sinsin;
- 2 (h) Pamutan;
- 3 (i) Babag;
- 4 (j) Buot-taup;
- 5 (k) Tag-bao;
- 6 (l) Pung-ol Sibugay;
- 7 (m) Tabunan;
- 8 (n) Bonbon;
- 9 (o) Bulacao;
- 10 (p) Poblacion Pardo;
- 11 (q) Kinasang-an;
- 12 (r) Quiot;
- 13 (s) Tisa;
- 14 (t) Punta Princesa;
- 15 (u) Labangon; and
- 16 (v) Guadalupe.

17 The current Second (2nd) Legislative District of Cebu City, which shall
18 continue to be designated as such, shall be composed of the following
19 barangays, to wit:

- 20 (a) Inayawan;
- 21 (b) Cogon Pardo;
- 22 (c) Basak Pardo;
- 23 (d) Basak San Nicolas;
- 24 (e) Mambaling, including the South Reclamation Properties (SRP);
- 25 (f) Duljo-Fatima;
- 26 (g) Sawang Calero;
- 27 (h) San Nicolas Proper;

- 1 (i) Pahina San Nicolas;
- 2 (j) Suba;
- 3 (k) Pasil; and
- 4 (l) Calamba.

5 SEC. 2. For the purpose of this Act, the newly created legislative
6 district of Cebu City shall elect a Representative and a new set of eight (8)
7 members of the sangguniang panlungsod who are residents of the district.
8 Their election into office shall be held to coincide with the national elections
9 after the effectivity of this Act.

10 SEC. 3. *Rules and Regulations.* – The Commission on Elections shall
11 issue the necessary rules and regulations to implement this Act.

12 SEC. 4. *Repealing Clause.* – All laws, rules and regulations which are
13 inconsistent with this Act are hereby repealed, amended or modified
14 accordingly.

15 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
16 its publication in at least two (2) newspapers of general circulation.
