AN ACT SUBDIVIDING THE ONE-BARANGAY MUNICIPALITY OF DUMALNEG IN THE PROVINCE OF ILOCOS NORTE INTO THREE (3) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY KALAW, BARANGAY CABARITAN AND BARANGAY QUIBEL

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Subdivision of the One-Barangay Municipality of*
2 *Dumalneg.* – The One-Barangay Municipality of Dumalneg in the Province
3 of Ilocos Norte is hereby subdivided into three (3) distinct and independent
4 barangays to be known as Barangay Kalaw, Barangay Cabaritan and Barangay
5 Quibel.

6 SEC. 2. *Composition.* – The existing puroks and sitios shall comprise
7 the new barangays herein created as follows:

8 (a) Barangay Kalaw – Barangay Kalaw shall be composed of Purok
9 Crisalita, Purok Saniata, Sitio Pacac, Sitio Banbanag, Sitio Sta. Maria, Sitio
10 Sisilungen, Sitio As-asaan, Sitio Nasduan, Sitio Nappud, Sitio Nanguratao and
11 Sitio Siraong;

1 (b) Barangay Cabaritan – Barangay Cabaritan shall be composed of
2 Purok Timpuyog, Poblacion, Sitio Alilem, Sitio Cabaritan, Sitio Capcapitan,
3 Sitio Tapauan, *Sitio Immalsung and Sitio Mangadamay*; and

4 (c) Barangay Quibel – Barangay Quibel shall be composed of Purok
5 Namnama, Purok Danggayan, Purok Regta, Sitio Namoc, Sitio Arapang, Sitio
6 Nalames, Sitio Baracbac, Sitio Bobog and Sitio Baset.

7 SEC. 3. *Existing Boundaries.* – The existing boundaries of the
8 different puroks and sitios enumerated in the immediately preceding section
9 shall be retained and maintained.

10 SEC. 4. *Seat of the Municipal Government.* – The seat of the
11 municipal government shall be at Poblacion, Barangay Cabaritan.

12 SEC. 5. *Conduct and Supervision of the Plebiscite.* – The
13 Commission on Elections (COMELEC) shall conduct and supervise the
14 plebiscite to be held in the entire Municipality of Dumalneg, Province of
15 Ilocos Norte within one hundred eighty (180) days from the effectivity of this
16 Act.

17 SEC. 6. *Barangay Officials.* – The first set of officials of the
18 barangays shall be appointed by the provincial governor, in consultation with
19 the Representative of the District, and shall hold office until such time that
20 their successors have been duly elected and qualified.

21 SEC. 7. *Public Infrastructure and Facilities.* – All existing public
22 infrastructure and facilities for public use existing therein at the time of the
23 approval of this Act are hereby transferred without cost or compensation to and
24 shall be administered by the new barangays.

25 SEC. 8. *Internal Revenue Allotment Shares.* – The Municipality of
26 Dumalneg and all the barangays herein created shall be entitled to Internal
27 Revenue Allotment (IRA) shares pursuant to Section 285 of Republic Act

1 No. 7160, as amended, otherwise known as the Local Government Code of
2 1991.

3 SEC. 9. *Effectivity.* -- This Act shall take effect fifteen (15) days after
4 its publication in any newspaper of general circulation.
