### AN ACT PROVIDING FOR THE REAPPORTIONMENT OF LEGISLATIVE DISTRICTS IN THE PROVINCE OF LEYTE

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1       SECTION 1. *Legislative Districts.* — The Province of Leyte, which  
2 shall have six (6) legislative districts to commence in the next national and  
3 local elections after the effectivity of this Act, is hereby reapportioned without  
4 change in the composition to be made in the First, Third and Fourth Legislative  
5 Districts as follows:

6       FIRST LEGISLATIVE DISTRICT:

7       (a) City of Tacloban;

8       (b) Alang-alang;

9       (c) Babatngon;

10       (d) Palo;

11       (e) San Miguel;

12       (f) Santa Fe;

(g) Tanauan; and

(h) Tolosa.

SECOND LEGISLATIVE DISTRICT:

(a) Burauen;

(b) Dagami;

(c) Dulag;

(d) Julita;

(e) La Paz;

(f) Mac Arthur;

(g) Mayorga; and

(h) Tabontabon.

THIRD LEGISLATIVE DISTRICT:

(a) Calubian;

(b) Leyte;

(c) San Isidro;

(d) Tabango; and

(e) Villaba.

FOURTH LEGISLATIVE DISTRICT:

(a) City of Ormoc;

(b) Albuera;

(c) Isabel;

(d) Kanangga;

(e) Matag-ob;

(f) Merida; and

(g) Palompon.

FIFTH LEGISLATIVE DISTRICT:

(a) Abuyog;

(b) Bato;

- (c) Baybay;
- (d) Hilongos;
- (e) Hindang;
- (f) Inopacan;
- (g) Javier;
- (h) Mahaplag; and
- (i) Matalom.

SIXTH LEGISLATIVE DISTRICT:

- (a) Barugo;
- (b) Capoocan;
- (c) Carigara;
- (d) Jaro;
- (e) Pastrana; and
- (f) Tunga.

SEC. 2. *Rules and Regulations.* — The Commission on Elections shall issue the necessary rules and regulations to implement this Act.

SEC. 3. *Repealing Clause.* — All laws, rules and regulations which are inconsistent with this Act are hereby repealed, amended or modified accordingly.

SEC. 4. *Effectivity.* — This Act shall take effect fifteen (15) days after its publication in any newspaper of general circulation.
