AN ACT SUBDIVIDING BARANGAY BAGONG SILANG (BARANGAY NO. 176) IN THE CITY OF CALOOCAN INTO SEVEN (7) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY 176-A, BARANGAY 176-B, BARANGAY 176-C, BARANGAY 176-D, BARANGAY 176-E, BARANGAY 176-F AND BARANGAY 176-G

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Subdivision of Barangay Bagong Silang (Barangay*
2 *No. 176).* – Barangay Bagong Silang (Barangay No. 176) in the City of
3 Caloocan is hereby subdivided into seven (7) distinct and independent
4 barangays to be known as Barangay 176-A, Barangay 176-B, Barangay 176-C,
5 Barangay 176-D, Barangay 176-E, Barangay 176-F and Barangay 176-G.

6 SEC. 2. *Composition and Boundaries.* – The existing puroks or
7 phases of Barangay Bagong Silang (Barangay No. 176) shall comprise the new
8 barangays herein created as follows:

- 9 (a) Barangay 176-A shall be composed of Phases I and II;
10 (b) Barangay 176-B shall be composed of Phases III and V;

- 1 (c) Barangay 176-C shall be composed of Phase IV;
2 (d) Barangay 176-D shall be composed of Phase VII;
3 (e) Barangay 176-E shall be composed of Phase VIII;
4 (f) Barangay 176-F shall be composed of Phase IX; and
5 (g) Barangay 176-G shall be composed of Phase X.

6 SEC. 3. *Conduct and Supervision of Plebiscite.* – The Commission on
7 Elections (COMELEC) shall conduct and supervise the plebiscite to be held in
8 Barangay Bagong Silang (Barangay No. 176) in the City of Caloocan within
9 sixty (60) days from the effectivity of this Act.

10 The expenses for such plebiscite shall be charged against the
11 Contingency Fund or any unexpended budget of the current year of the
12 COMELEC.

13 SEC. 4. *Barangay Officials.* – The first set of officials of the
14 barangays shall be appointed by the President of the Philippines, in
15 consultation with the Representative of the District, and shall hold office until
16 such time that their successors have been duly elected and qualified.

17 SEC. 5. *Public Infrastructures and Facilities.* – All existing public
18 infrastructures and facilities for public use existing therein at the time of the
19 approval of this Act are hereby transferred without cost or compensation to and
20 shall be administered by the new barangays.

21 SEC. 6. *Internal Revenue Allotment (IRA) Shares.* – All the barangays
22 herein created shall be entitled to Internal Revenue Allotment (IRA) shares
23 pursuant to Section 285 of Republic Act No. 7160, as amended, otherwise
24 known as the Local Government Code of 1991.

25 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15) days after
26 its publication in any newspaper of general circulation.
