AN ACT PROVIDING FOR THE ESTABLISHMENT OF THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) TRAINING AND ACCREDITATION CENTER IN THE CITY OF SAN JOSE DEL MONTE, BULACAN AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. Short Title. This Act shall be known as the "San Jose Del Monte City TESDA Training and Accreditation Center Act of 2012".
  - SEC. 2. Establishment. There is hereby established the Technical Education and Skills Development Authority (TESDA) Training and Accreditation Center in the City of San Jose Del Monte, Bulacan under the supervision of the TESDA, hereinafter referred to as the Training and Accreditation Center.
    - SEC. 3. General Mandate. The Training and Accreditation Center shall primarily provide technical and vocational training and skills development programs to low-income families and out-of-school youth in the

development of the city and to meet the needs of both local and international

- SEC. 4. Curricular Offerings. The Training and Accreditation Center shall offer short-term certificate courses in Shielded Metal Arc Welding; Auto Servicing; Plumbing; Refrigeration and Airconditioning; Building Wiring; Masonry; Commercial Cooking; Housekeeping; Household Management and other technical-vocational courses within its areas of
  - SEC. 5. School Site. The Training and Accreditation Center shall be built on a two (2)-hectare portion of the National Housing Authority (NHA) property in Barangay San Manuel, City of San Jose Del Monte, Bulacan, which is covered by TCT No. 366649 (M) of the Register of Deeds of Meycauayan, Bulacan, and under usufruct agreement among the NHA, the provincial government of Bulacan and the Office of the Lone Congressional District of San Jose Del Monte, Bulacan.
  - SEC. 6. Administration. The Training and Accreditation Center shall be headed by a Technical Vocational Administrator under the supervision of the TESDA.
  - SEC. 7. Appropriations. The Director General of the TESDA shall include in the TESDA's program the establishment of the TESDA Training and Accreditation Center, the funding of which shall be included in the annual General Appropriations Act. The city government of San Jose Del Monte, Bulacan shall set aside funds from any available local revenues in an amount deemed appropriate by the city officials concerned as subsidy for the operationalization of the Training and Accreditation Center.

8	SEC. 10. Repealing Clause All laws, presidential decrees, executive						
9	orders, rules and regulations contrary to or inconsistent with the provisions o						
10	this Act are hereby repealed or modified accordingly.						
11	SEC. 11. Effectivity Clause This Act shall take effect fifteen (15)						
12	days after its publication in at least two (2) newspapers of general circulation.
