AN ACT CREATING FOUR (4) ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURT AND TWO (2) ADDITIONAL BRANCHES OF THE MUNICIPAL TRIAL COURT IN CITIES IN THE THIRD JUDICIAL REGION TO BE STATIONED IN SAN JOSE CITY, THE SCIENCE CITY OF MUÑOZ, AND IN THE MUNICIPALITY OF RIZAL, PROVINCE OF NUEVA ECIJA, FURTHER AMENDING FOR THE PURPOSE SECTION 14, PARAGRAPH (C) AND SECTION 29 OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Four (4) additional Regional Trial Court branches and two
2 (2) additional Municipal Trial Court in Cities branches are hereby created in
3 the Third Judicial Region to be stationed in the Province of Nueva Ecija, with
4 seats at:

3 The Supreme Court shall assign the respective branch numbers of the
4 newly-created branches of the Regional Trial Court and Municipal Trial Court
5 in Cities in the Third Judicial Region.

6 SEC. 2. The Chief Justice of the Supreme Court, in coordination with
7 the Secretary of the Department of Justice, shall immediately include in the
8 Court's program the implementation of this Act. The funding therefor shall
9 likewise be included in the annual General Appropriations Act.

10 SEC. 3. Section 14(c) and Section 29 of Batas Pambansa Blg. 129,
11 otherwise known as "The Judiciary Reorganization Act of 1980", as amended,
12 and all other laws, rules and regulations which are inconsistent with this Act
13 are hereby amended, repealed or modified accordingly.

14 SEC. 4. This Act shall take effect fifteen (15) days after its complete
15 publication in the *Official Gazette* or in two (2) newspapers of general
16 circulation.
