AN ACT CHANGING THE NAME OF ALCANTARA NATIONAL TRADE SCHOOL TO ROMBLON NATIONAL INSTITUTE OF TECHNOLOGY

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Renaming of a National Trade School.* – The name of
2 Alcantara National Trade School in the Municipality of Alcantara, Province of
3 Romblon is hereby changed to Romblon National Institute of Technology.

4 SEC. 2. *Location of the Main Campus.* – The main campus of the
5 Romblon National Institute of Technology shall continue to remain in its
6 present location in the Municipality of Alcantara, Province of Romblon.

7 SEC. 3. *Effectivity.* – This Act shall take effect fifteen (15) days after
8 its publication in the *Official Gazette*.
