AN ACT CONVERTING THE SADANGA NATIONAL HIGH SCHOOL  
IN BARANGAY POBLACION, MUNICIPALITY OF SADANGA,  
MOUNTAIN PROVINCE INTO A NATIONAL TECHNICAL-  
VOCATIONAL HIGH SCHOOL TO BE KNOWN AS SADANGA  
NATIONAL TECHNICAL-VOCATIONAL AND SKILLS  
TRAINING HIGH SCHOOL AND APPROPRIATING FUNDS  
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Sadanga National High School in Barangay  
2 Poblacion, Municipality of Sadanga, Mountain Province is hereby converted  
3 into a national technical-vocational high school to be known as Sadanga  
4 National Technical-Vocational and Skills Training High School.

5           SEC. 2. All personnel, assets, liabilities and records of the Sadanga  
6 National High School are hereby transferred to and absorbed by the Sadanga  
7 National Technical-Vocational and Skills Training High School.

8           SEC. 3. The Secretary of Education shall immediately include in the  
9 Department's program the operationalization of the Sadanga National  
10 Technical-Vocational and Skills Training High School, the initial funding of  
11 which shall be charged against the current year's appropriation of the Sadanga

1 National High School. Thereafter, the amount necessary for the continued  
2 operation of the school shall be included in the annual General Appropriations  
3 Act.

4 SEC. 4. The Secretary of Education shall issue rules and regulations  
5 necessary to carry out the purpose of this Act.

6 SEC. 5. This Act shall take effect fifteen (15) days after its publication  
7 in the *Official Gazette* or in a newspaper of general circulation.
