





POBLACION 2 IN THE MUNICIPALITY OF VILLANUEVA,

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Creation of Barangay Poblacion 2.* - There is hereby
2 created a barangay to be known as Barangay Poblacion 2 in the Municipality
3 of Villanueva, Province of Misamis Oriental.

4 SEC. 2. *Territorial Boundaries.* - The technical description of
5 Barangay Poblacion 2 shall be as follows:

3 **SEC. 3. *Conduct and Supervision of Plebiscite.*** – The plebiscite
4 conducted and supervised by the Commission on Elections (COMELEC)
5 pursuant to Provincial Ordinance No. 914-2006 of the Sangguniang
6 Panlalawigan of the Province of Misamis Oriental, which ratified the creation
7 of Barangay Poblacion 2 as proclaimed by the Plebiscite Board of Carvassers
8 on April 22, 2006, shall serve as substantial compliance with the plebiscite
9 requirement under Section 10 of Republic Act No. 7160, as amended,
10 otherwise known as the “Local Government Code of 1991”.

11 **SEC. 4. *Barangay Officials.*** – The incumbent elected barangay
12 officials of Barangay Poblacion 2, Municipality of Villanueva, Province of
13 Misamis Oriental shall continue to hold office until such time that their
14 successors have been duly elected and qualified.

15 **SEC. 5. *Public Infrastructures and Facilities.*** – All existing public
16 infrastructures and facilities for public use existing therein at the time of the
17 approval of this Act are hereby transferred without cost or compensation to the
18 new barangay and shall be administered by the same.

19 **SEC. 6. *Internal Revenue Allotment Shares.*** – Barangay Poblacion 2
20 shall be entitled to Internal Revenue Allotment (IRA) shares pursuant to
21 Section 285 of Republic Act No. 7160, as amended, otherwise known as the
22 “Local Government Code of 1991”.

23 **SEC. 7. *Effectivity.*** – This Act shall take effect fifteen (15) days after
24 its publication in the *Official Gazette* or in a newspaper of general circulation.

Approved,
