AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY
LIWON IN THE MUNICIPALITY OF ASIPULO, PROVINCE OF
IFUGAO

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Creation of Barangay Liwon.* – The Special Economic
2 Zone of Liwon in Barangay Amduntog is hereby separated from Barangay
3 Amduntog and constituted into a new barangay to be known as Barangay
4 Liwon in the Municipality of Asipulo, Province of Ifugao.

5 The technical description of Barangay Liwon shall be as follows:

6 “Bounded on the North by barangays Amduntog and Nungawa, on the
7 South by Barangay Namal and the Municipality of Tinoc, on the East by
8 Barangay Antipolo and on the West by Barangay Julongan in the Municipality
9 of Kiangan.”

10 SEC. 2. *Conduct and Supervision of Plebiscite.* – Pursuant to Section
11 10 of Republic Act No. 7160, as amended, otherwise known as the “Local
12 Government Code of 1991”, the new barangay shall exist upon obtaining a

1 majority of the votes cast in a plebiscite to be conducted and supervised by the
2 Commission on Elections (COMELEC) in Barangay Amduntog, Municipality
3 of Asipulo, Province of Ifugao within ninety (90) days from the effectivity of
4 this Act.

5 The expenses for the plebiscite shall be borne by the Municipality of
6 Asipulo, Province of Ifugao.

7 SEC. 3. *Barangay Officials.* – The first set of barangay officials of
8 Barangay Liwon shall be appointed by the provincial governor of the Province
9 of Ifugao and shall hold office until such time that the new set of officers have
10 been duly elected and qualified.

11 SEC. 4. *Public Infrastructures and Facilities.* -- All existing public
12 infrastructures and facilities for public use existing therein at the time of the
13 approval of this Act are hereby transferred without cost or compensation to and
14 shall be administered by the new barangay.

15 SEC. 5. *Internal Revenue Allotment Shares.* – Barangay Liwon shall
16 be entitled to Internal Revenue Allotment (IRA) shares pursuant to Section 285
17 of Republic Act No. 7160, as amended, otherwise known as the “Local
18 Government Code of 1991”.

19 SEC. 6. *Effectivity.* – This Act shall take effect fifteen (15) days after
20 its publication in the *Official Gazette* or in a newspaper of general circulation.
