AN ACT SEPARATING THE SITIOS OF ILEB, NEW COLAYO VILLAGE, KINAMA AND NAMBARAN DAYA FROM BARANGAY NAMBARAN, CITY OF TABUK, PROVINCE OF KALINGA AND CONSTITUTING THEM INTO A SEPARATE AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY NAMBARAN EAST

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. *Creation of Barangay Nambaran East.* – The sitios of  
2   Ileb, New Colayo Village, Kinama and Nambaran Daya are hereby separated  
3   from Barangay Nambaran in the City of Tabuk, Province of Kalinga to  
4   constitute a new barangay to be known as Barangay Nambaran East.

5           SEC. 2. *Conduct and Supervision of Plebiscite.* – Pursuant to Section  
6   10 of Republic Act No. 7160, as amended, otherwise known as the “Local  
7   Government Code of 1991”, the new Barangay Nambaran East shall exist upon  
8   the approval by a majority of the votes cast by the qualified voters of Barangay  
9   Nambaran in a plebiscite to be conducted and supervised by the Commission  
10   on Elections (COMELEC) in the area affected, within ninety (90) days from  
11   the effectivity of this Act.

1           The amount necessary for the conduct of such plebiscite shall be borne  
2 by the City of Tabuk, Province of Kalinga.

3           **SEC. 3. *Barangay Officials.*** – The first set of officials of Barangay  
4 Nambaran East shall be appointed by the Provincial Governor and shall hold  
5 office until such time that their successors have been duly elected and  
6 qualified.

7           **SEC. 4. *Public Infrastructures and Facilities.*** – All existing public  
8 infrastructures and facilities for public use existing therein at the time of the  
9 approval of this Act are hereby transferred without cost or compensation to and  
10 shall be administered by the new barangay.

11           **SEC. 5. *Internal Revenue Allotment Shares.*** – Barangay Nambaran  
12 East shall be entitled to Internal Revenue Allotment shares pursuant to Section  
13 285 of Republic Act No. 7160, as amended, otherwise known as the “Local  
14 Government Code of 1991”.

15           **SEC. 6. *Effectivity.*** – This Act shall take effect fifteen (15) days after  
16 its publication in any newspaper of general circulation.
