
**"AN ACT





AN ACT ESTABLISHING A DISTRICT OFFICE OF THE LAND
TRANSPORTATION OFFICE IN THE PROVINCE OF
SARANGANI AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established in the Municipality of Alabel,
2 Province of Sarangani a District Office of the Land Transportation Office
3 (LTO).

4 SEC. 2. The LTO District Office shall be located in an area in the
5 municipality that is accessible to the people.

6 SEC. 3. The head of the LTO District Office shall be appointed by the
7 Secretary of Transportation and Communications in accordance with existing
8 laws.

9 SEC. 4. The Department of Transportation and Communications shall
10 promulgate the necessary rules and regulations for the effective
11 implementation of this Act.

1 **SEC. 5.** The Secretary of Transportation and Communications shall
2 include in the Department's program the operationalization of the District
3 Office of the LTO in the Municipality of Alabel, Province of Sarangani, the
4 funding of which shall be included in the annual General Appropriations Act.

5 **SEC. 6.** This Act shall take effect fifteen (15) days after its publication
6 in the *Official Gazette* or in a newspaper of general circulation.
