
"AN ACT





AN ACT ESTABLISHING A DISTRICT OFFICE OF THE LAND
TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF
CARMONA, PROVINCE OF CAVITE AND APPROPRIATING
FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. A Land Transportation Office (LTO) District Office in the
2 Municipality of Carmona, Province of Cavite is hereby established.

3 SEC. 2. The Department of Transportation and Communications shall
4 issue necessary rules and regulations to implement the establishment of the
5 said office.

6 SEC. 3. The amount needed for the operationalization of the LTO
7 District Office in the Municipality of Carmona, Province of Cavite shall be
8 included in the annual General Appropriations Act.

9 SEC. 4. This Act shall take effect fifteen (15) days after its publication
10 in the *Official Gazette* or in a newspaper of general circulation.
