AN ACT CONVERTING THE CEBU NORMAL UNIVERSITY-
MEDELLIN SATELLITE CAMPUS IN THE MUNICIPALITY OF
MEDELLIN, PROVINCE OF CEBU INTO A REGULAR CAMPUS
OF THE CEBU NORMAL UNIVERSITY TO BE KNOWN AS THE
CEBU NORMAL UNIVERSITY-MEDELLIN CAMPUS AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Conversion.* — The Cebu Normal University (CNU)-
2 Medellin Satellite Campus in the Municipality of Medellin, Province of Cebu
3 is hereby converted into a regular campus of the Cebu Normal University to be
4 known as the Cebu Normal University-Medellin Campus.

5 SEC. 2. *Curricular Offerings.* — The CNU-Medellin Campus shall
6 offer undergraduate and graduate and short-term courses and other related and
7 relevant fields of study within its areas of specialization to meet the needs of
8 the province and of the region.

9 SEC. 3. *Board of Regents.* — The governance of the CNU-Medellin
10 Campus shall be vested exclusively in the Board of Regents (BOR) created

1 under Republic Act No. 8688, otherwise known as the Cebu Normal
2 University (CNU) and Republic Act No. 8292, otherwise known as the
3 “Higher Education Modernization Act of 1997” that govern the CNU. All
4 policies, rules and regulations approved by the CNU-BOR shall be applied to
5 CNU-Medellin Campus.

6 SEC. 4. *The Campus Administrator.* – The administration of the
7 CNU-Medellin Campus shall be the responsibility of the Campus
8 Administrator who shall be appointed by the CNU President and confirmed by
9 the BOR.

10 The Campus Administrator shall serve on a full-time basis and shall
11 hold office for a term of three (3) years. The Campus Administrator shall be
12 eligible for reappointment for another term: *Provided,* That the Campus
13 Administrator shall not be over sixty-two (62) years old at the time of
14 appointment to qualify for reappointment or term extension: *Provided, further,*
15 That the Campus Administrator shall not have reached the age of seventy (70)
16 years old. The Campus Administrator shall have at least an academic rank of
17 associate professor and at least three (3) years of experience as Department
18 Chairperson, Director or Vice President of a college/unit.

19 SEC. 5. *Powers and Duties of the Campus Administrator.* – The
20 powers and duties of the Campus Administrator of the CNU-Medellin Campus
21 shall be similar to the powers and duties of the Campus Administrators in other
22 CNU campuses.

23 The Campus Administrator of the CNU-Medellin Campus shall
24 represent the CNU-Medellin Campus in the Administrative Council and
25 Academic Council of the University.

26 SEC. 6. *Assets, Liabilities and Personnel.* – All assets, real and
27 personal, personnel and records of the CNU-Medellin Campus
28 (satellite campus) in the Municipality of Medellin, Province of Cebu, as well as

1 liabilities or obligations, are hereby transferred to the CNU-Medellin Campus.
2 The positions, rights and security of tenure of faculty members and personnel
3 therein employed under existing laws prior to the conversion into a regular
4 campus shall be respected.

5 All parcels of land belonging to the government occupied by the
6 CNU-Medellin Satellite Campus in the Municipality of Medellin are hereby
7 transferred to the CNU-Medellin Campus, and shall be titled under that name:
8 *Provided*, That should the campus or the University cease to exist or be
9 abolished or should such parcels of land aforementioned be no longer needed
10 by the University, the same shall revert to the local government units
11 concerned.

12 SEC. 7. *Fiscal Autonomy of the CNU-Medellin Campus.* -- No portion
13 of the funds appropriated or allocated for the CNU-Medellin Campus shall be
14 disbursed by the CNU Administration and all other incomes and earnings of
15 the CNU-Medellin Campus shall remain with the said campus.

16 SEC. 8. *Appropriations.* -- The amount necessary to carry out the
17 initial implementation of this Act shall be charged against the current year's
18 funding of the CNU-Medellin Satellite Campus provided by the Municipality
19 of Medellin, Province of Cebu. The Municipality of Medellin shall continue to
20 provide the same assistance until such time that the full funding requirements
21 of the CNU-Medellin Campus is included in the annual General
22 Appropriations Act (GAA).

23 SEC. 9. *Implementing Rules and Regulations.* -- Within one hundred
24 twenty (120) days from the approval of this Act, the BOR of the CNU,
25 in consultation with the Commission on Higher Education, shall promulgate
26 the rules and regulations implementing the provisions of this Act. The
27 implementing rules and regulations issued pursuant to this section shall take
28 effect thirty (30) days after the effectivity of this Act.

1 SEC. 10. *Repealing Clause.* – All laws or parts thereof inconsistent
2 with any provision of this Act shall be deemed repealed or modified
3 accordingly.

4 SEC. 11. *Separability Clause.* – If any provision of this Act is
5 declared unconstitutional, the remainder of this Act or provisions not affected
6 thereby shall remain in full force and effect.

7 SEC. 12. *Effectivity.* – This Act shall take effect fifteen (15) days after
8 its publication in the *Official Gazette* or in a newspaper of general circulation.
