AN ACT ESTABLISHING A LAND TRANSPORTATION OFFICE (LTO)  
DISTRICT OFFICE IN THE CITY OF SIPALAY, PROVINCE OF  
NEGROS OCCIDENTAL AND APPROPRIATING FUNDS  
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. There shall be established, under the supervision of the  
2 Land Transportation Office (LTO) Main Office in Quezon City, a district  
3 office of the LTO in the City of Sipalay, Province of Negros Occidental.

4           SEC. 2. The Secretary of the Department of Transportation and  
5 Communications (DOTC) shall immediately include in the Department's  
6 programs the operationalization of the LTO District Office in the City of  
7 Sipalay, Province of Negros Occidental, the funding of which shall be included  
8 in the annual General Appropriations Act.

9           SEC. 3. The Secretary of the DOTC shall issue rules and regulations  
10 necessary for the effective implementation of this Act.

11           SEC. 4. This Act shall take effect fifteen (15) days after its publication  
12 in the *Official Gazette* or in a national newspaper of general circulation.

AN ACT CONVERTING THE SATELLITE OFFICE OF THE LAND  
TRANSPORTATION OFFICE (LTO) IN THE CITY OF BAYUGAN,  
PROVINCE OF AGUSAN DEL SUR INTO A REGULAR DISTRICT  
OFFICE TO BE KNOWN AS THE LTO DISTRICT OFFICE OF  
BAYUGAN CITY, AGUSAN DEL SUR AND APPROPRIATING  
FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

- 1           SECTION 1. The satellite office of the Land Transportation Office  
2 (LTO) in the City of Bayugan, Province of Agusan del Sur is hereby converted  
3 into a regular district office to be known as the LTO District Office of  
4 Bayugan City, Agusan del Sur.
- 5           SEC. 2. The Secretary of the Department of Transportation and  
6 Communications (DOTC) shall include in the Department's programs the  
7 operationalization of the LTO District Office in the City of Bayugan, Province  
8 of Agusan del Sur, the funding of which shall be included in the annual  
9 General Appropriations Act.

1           SEC. 3. The Secretary of the DOTC shall issue rules and regulations  
2 necessary for the effective implementation of this Act.

3           SEC. 4. This Act shall take effect fifteen (15) days after its  
4 publication in the *Official Gazette* or in a national newspaper of general  
5 circulation.
