AN ACT CONVERTING THE SATELLITE OFFICE OF THE LAND TRANSPORTATION OFFICE (LTO) IN THE CITY OF BAYUGAN, PROVINCE OF AGUSAN DEL SUR INTO A REGULAR DISTRICT OFFICE TO BE KNOWN AS THE LTO DISTRICT OFFICE OF BAYUGAN CITY, AGUSAN DEL SUR AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The satellite office of the Land Transportation Office (LTO) in the City of Bayugan, Province of Agusan del Sur is hereby converted into a regular district office to be known as the LTO District Office of Bayugan City, Agusan del Sur.

SEC. 2. The Secretary of the Department of Transportation and Communications (DOTC) shall include in the Department's programs the operationalization of the LTO District Office in the City of Bayugan, Province of Agusan del Sur, the funding of which shall be included in the annual General Appropriations Act.
