AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY
POBLACION 2 IN THE MUNICIPALITY OF VILLANUEVA,
PROVINCE OF MISAMIS ORIENTAL

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Creation of Barangay Poblacion 2.* - There is hereby
2 created a barangay to be known as Barangay Poblacion 2 in the Municipality
3 of Villanueva, Province of Misamis Oriental.

4 SEC. 2. *Territorial Boundaries.* - The technical description of
5 Barangay Poblacion 2 shall be as follows:

23 SEC. 3. *Conduct and Supervision of Plebiscite.* – The plebiscite
24 conducted and supervised by the Commission on Elections (COMELEC)
25 pursuant to Provincial Ordinance No. 914-2006 of the Sangguniang
26 Panlalawigan of the Province of Misamis Oriental, which ratified the creation
27 of Barangay Poblacion 2 as proclaimed by the Plebiscite Board of Canvassers
28 on April 22, 2006, shall serve as substantial compliance to the plebiscite

1 requirement under Section 10 of Republic Act No. 7160, as amended,
2 otherwise known as the "Local Government Code of 1991".

3 SEC. 4. *Barangay Officials.* – The incumbent elected barangay
4 officials of Barangay Poblacion 2, Municipality of Villanueva, Province of
5 Misamis Oriental shall continue to hold office until such time that their
6 successors have been duly elected and qualified.

7 SEC. 5. *Public Infrastructure and Facilities.* – All public infrastructure
8 and facilities for public use existing therein at the time of the approval of this
9 Act are hereby transferred without cost or compensation to the new barangay
10 and shall be administered by the same.

11 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay Poblacion 2
12 shall be entitled to Internal Revenue Allotment (IRA) shares pursuant to
13 Section 285 of Republic Act No. 7160, as amended, otherwise known as the
14 "Local Government Code of 1991".

15 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15) days after
16 its publication in any newspaper of general circulation.
