AN ACT RENAMING THE DON HONORIO VENTURA TECHNOLOGICAL STATE UNIVERSITY (DHVTSU) IN THE MUNICIPALITY OF BACOLOR, PROVINCE OF PAMPANGA AS THE DON HONORIO VENTURA STATE UNIVERSITY (DHVSU), AND EXPANDING ITS CURRICULAR OFFERINGS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9832, ENTITLED "AN ACT CONVERTING THE DON HONORIO VENTURA COLLEGE OF ARTS AND TRADES IN THE MUNICIPALITY OF BACOLOR, PROVINCE OF PAMPANGA INTO A STATE UNIVERSITY TO BE KNOWN AS THE DON HONORIO VENTURA TECHNOLOGICAL STATE UNIVERSITY (DHVTSU) AND APPROPRIATING FUNDS THEREFOR"

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The Don Honorio Ventura Technological State University  
2 (DHVTSU) in the Municipality of Bacolor, Province of Pampanga is hereby  
3 renamed as the Don Honorio Ventura State University (DHVSU).

4           SEC. 2. *General Mandate.* – The University shall primarily provide  
5 advanced instruction and professional training in education, engineering,  
6 science and technology, arts and humanities, information and communications  
7 technology, liberal arts, medical, health-related programs, and other relevant  
8 fields of study. It shall also undertake research, extension services, and

1 production activities in support of the socioeconomic development of the  
2 Province of Pampanga and provide progressive leadership in its areas of  
3 specialization.

4       SEC. 3. *Curricular Offerings.* – The University shall offer  
5 undergraduate and graduate courses in the fields of education, engineering,  
6 science and technology, arts and humanities, information and communications  
7 technology, liberal arts, legal management, law, medicine sciences, health-  
8 related courses, entrepreneurial program, creative industries, travel  
9 management, culinary management, and other relevant courses within its areas  
10 of specialization and according to its capabilities, as the Board of Regents may  
11 deem necessary to carry out its objectives, in order to meet the needs of the  
12 Province of Pampanga and Region III.

13       SEC. 4. *Repealing Clause.* – All provisions of Republic Act No. 9832  
14 referring to the name of Don Honorio Ventura Technological State University  
15 are hereby modified accordingly.

16       SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after  
17 its publication in the *Official Gazette* or in a newspaper of general circulation.
