AN ACT DIVIDING BARANGAY ADAMS IN THE MUNICIPALITY OF ADAMS, PROVINCE OF ILOCOS NORTE INTO TWO (2) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY ADAN AND BARANGAY BUCAROT

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. *Division of Barangay Adams.* – Barangay Adams  
2 in the Municipality of Adams, Province of Ilocos Norte is hereby  
3 divided into two (2) distinct and independent barangays to be  
4 known as Barangay Adan and Barangay Bucarot.

5           SEC. 2. *Composition.* – The existing puroks and sitios shall  
6 comprise the new barangays herein created as follows:

7           (a) Barangay Adan. – Barangay Adan shall be composed of  
8 areas covered by Sitios Maligligay, Sinidangan, Malaggao, Lower  
9 Uno, Upper Uno, Dos, Tres, Marunruno, Baset, Arimit, Bobog,  
10 Sisilungen, Gayang, Nanukulan, Balinawang, Ubay, Lulugen,  
11 Adan, Buaw, Anat, Anuplig, Cabacan, Masi, Pao, Mabolo, Budabud,  
12 Inapad and Magnas; and

1 (b) Barangay Bucarot. - Barangay Bucarot shall be  
 2 composed of areas covered by Sitios Cadisan, Bucarot, Nagbayogan,  
 3 Sioet, Cawcawat, Linao, Ingin, Panuktukan, Pungan, Burburan,  
 4 Salongsong, Masi, Gasas and Baay.

5 SEC. 3. *Technical Description.* - The territorial boundaries  
 6 of each barangay created in the immediately preceding section shall  
 7 be identified as follows:

8 (a) Barangay Adan

9 Bounded on the South, along lines 1 to 13, by Barangay  
 10 Bucarot;

11 On the Southwest (SW), along line 13 to 14, by the  
 12 Municipality of Vintar;

13 On the West, along lines 14 to 16, by the Municipality of  
 14 Dumalneg;

15 On the North, along lines 16 to 18, by the Municipality of  
 16 Pagudpud; and

17 On the East, along line 18 to 1, by the Municipality of  
 18 Santa Paxedes, Province of Cagayan.

19 The technical description of Barangay Adan is as follows:

14           (b) Barangay Bucarot

15           Bounded on the South, along line 1 to 2, by the Municipality  
16 of Vintar;

17           On the West, along line 2 to 3, by the Municipality of  
18 Vintar;

19           On the North, along lines 3 to 15, by Barangay Adan;

20           On the Northeast (NE), along line 15 to 16, by the  
21 Municipality of Santa Praxedes, Province of Cagayan; and

22           On the Southeast (SE), along line 16 to 1, by the Municipality  
23 of Calanasan, Province of Apayao.

24           The technical description of Barangay Bucarot is  
25 as follows:

19 or less.

20           SEC. 4. *Seat of the Municipal Government.* – The seat of the  
21 municipal government shall be at the Poblacion, Barangay Adan.

22           SEC. 5. *Conduct and Supervision of the Plebiscite.* – The  
23 Commission on Elections (COMELEC) shall conduct and supervise  
24 the plebiscite to be held in the entire Municipality of Adams,  
25 Province of Ilocos Norte not later than one hundred twenty (120)  
26 days from the effectivity of this Act.

1           The expenses for the plebiscite shall be borne by the  
2 Municipality of Adams, Province of Ilocos Norte.

3           **SEC. 6. *Barangay Officials.*** – The first set of officials of the  
4 barangays shall be appointed by the Governor of the Province of  
5 Ilocos Norte, in consultation with the Representative of the District,  
6 and shall hold office until such time that their successors have been  
7 duly elected and qualified.

8           **SEC. 7. *Public Infrastructure and Facilities.*** – All public  
9 infrastructure and facilities for public use existing therein at the  
10 time of the approval of this Act are hereby transferred without cost  
11 or compensation to and shall be administered by the new  
12 barangays.

13           **SEC. 8. *Internal Revenue Allotment Shares.*** – Barangay  
14 Adan and Barangay Bucarot shall be entitled to Internal Revenue  
15 Allotment (IRA) shares pursuant to Section 285 of Republic  
16 Act No. 7160, as amended, otherwise known as the Local  
17 Government Code of 1991.

18           **SEC. 9. *Effectivity.*** – This Act shall take effect fifteen (15)  
19 days after its publication in the *Official Gazette* or in a newspaper of  
20 general circulation.
