AN ACT SEPARATING THE SITIO OF PANGAYLAN-IP
FROM BARANGAY POBLACION I IN THE MUNICIPALITY
OF SANTIAGO, PROVINCE OF AGUSAN DEL NORTE AND
CONSTITUTED AS A DISTINCT AND INDEPENDENT
BARANGAY TO BE KNOWN AS BARANGAY
PANGAYLAN-IP

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The Sitio of Pangaylan-Ip is hereby separated
2 from Barangay Poblacion I in the Municipality of Santiago, Province
3 of Agusan del Norte and constituted as a distinct and independent
4 barangay to be known as Barangay Pangaylan-Ip.

5 SEC. 2. The territorial boundaries of Barangay Pangaylan-Ip
6 are described as follows:

7 "Beginning from BLLM 1 about 1,326 meters
8 more or less N 70-30 E to point "1"; thence following due
9 east direction about 19,100.00 meters more or less until
10 it intersects the Provincial Boundary of Agusan del
11 Norte and Surigao del Sur in southeasterly direction

1 about 400.00 meters more or less to point "2"; thence
2 following due west direction about 19,100.00 meters
3 more or less to point "3"; thence following due north
4 until it intersects the point of beginning containing one
5 thousand nine hundred ten (1,910) hectares."

6 SEC. 3. The plebiscite conducted and supervised by the
7 Commission on Elections (COMELEC) in Barangay Poblacion I
8 pursuant to Provincial Ordinance No. 266-2010 of the Sangguniang
9 Panlalawigan of Agusan del Norte, which ratified the creation of
10 Barangay Pangaylan-Ip as proclaimed by the Plebiscite Board of
11 Canvassers on March 5, 2011 shall serve as substantial compliance
12 with the plebiscite requirement under Section 10 of Republic Act
13 No. 7160, as amended, otherwise known as the "Local Government
14 Code of 1991".

15 SEC. 4. The incumbent barangay officials of Barangay
16 Pangaylan-Ip shall continue to hold office until such time that their
17 successors have been duly elected and qualified.

18 SEC. 5. All public infrastructure and facilities for public use
19 existing therein at the time of the approval of this Act are hereby
20 transferred without cost or compensation to and shall be
21 administered by the new Barangay Pangaylan-Ip.

22 SEC. 6. Barangay Pangaylan-Ip shall be entitled to Internal
23 Revenue Allotment (IRA) shares pursuant to Section 285 of
24 Republic Act No. 7160, as amended, otherwise known as the "Local
25 Government Code of 1991".

26 SEC. 7. This Act shall take effect fifteen (15) days after its
27 publication in the *Official Gazette* or in any newspaper of general
28 circulation.
