- AN ACT LOWERING THE OPTIONAL RETIREMENT AGE OF GOVERNMENT WORKERS FROM SIXTY (60) YEARS TO FIFTY-SIX (56) YEARS, AMENDING FOR THE PURPOSE SECTION 13-A OF REPUBLIC ACT NO. 8291, OTHERWISE KNOWN AS "THE GOVERNMENT SERVICE INSURANCE SYSTEM ACT OF 1997"
- Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
- 1 SECTION 1. Section 13-A of Republic Act No. 8291, otherwise
- 2 known as "The Government Service Insurance System Act of 1997",
- 3 is hereby amended to read as follows:
- 4 "SEC. 13-A. Conditions for Entitlement. A
- 5 member who retires from the service shall be entitled to

1	the retirement benefits enumerated in paragraph (a) of
2	Section 13 hereof: Provided, That SUCH MEMBER:
3	"(1) [he] has rendered at least fifteen (15) years of
4	service;
5	"(2) [he] is at least [sixty (60)] FIFTY-SIX (56)
6	years of age at the time of retirement; and
7	"(3) [he] is not receiving a monthly pension
8	benefit from permanent total disability."
9	SEC. 2. All laws, executive orders, letters of instruction, rules
0	and regulations or provisions thereof which are inconsistent with
1	the provisions of this Act are hereby repealed, amended, or modified
2	accordingly.
3	SEC. 3. This Act shall take effect fifteen (15) days after its
4	publication in the Official Gazette or in a newspaper of general
5	circulation.
