AN ACT DECLARING A PARCEL OF LAND OF THE PUBLIC DOMAIN LOCATED IN BARANGAY JORDAN, MUNICIPALITY OF VILLABA, PROVINCE OF LEYTE AS AGRICULTURAL LÁND OPEN TO DISPOSITION FOR AGRICULTURAL, RESIDENTIÁL, COMMERCIAL, INDUSTRIAL, OR OTHER PRODUCTIVE PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The parcel of land of the public domain located in
Barangay Jordan, Municipality of Villaba, Province of Leyte, consisting of
two hundred forty-seven thousand two hundred ninety (247,290) square
meters, more or less, is hereby declared an agricultural land open to
disposition for residential, agricultural, commercial, industrial, or other
productive purposes. Said parcel of land is more particularly described as
follows:
