AN ACT DECLARING A PARCEL OF LAND OF THE PUBLIC
DOMAIN LOCATED IN BARANGAY MAHAYAG,
MUNICIPALITY OF ISABEL, PROVINCE OF LEYTE AS
AGRICULTURAL LAND OPEN TO DISPOSITION FOR
AGRICULTURAL, RESIDENTIAL, COMMERCIAL,
INDUSTRIAL, OR OTHER PRODUCTIVE PURPOSES

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. The parcel of land of the public domain located in
2 Barangay Mahayag, Municipality of Isabel, Province of Leyte, consisting
3 of one hundred eighty thousand two hundred eighty-seven (180,287)
4 square meters, more or less, which is covered by Project Number 34,
5 Block K, Land Classification Map Number 647, is hereby declared an
6 agricultural land open to disposition for residential, agricultural,
7 commercial, industrial, or other productive purposes. Said parcel of land
8 is more particularly described as follows:

17 necessary rules and regulations for the effective implementation of this
