## H, No. 3688

BY REPRESENTATIVES FUA, DOMOGAN, BANAAG AND MITRA, PER COMMITTEE REPORT NO. 368

AN ACT EXCLUDING FROM THE BAGUIO TOWNSITE RESERVATION A PARCEL OF LAND LOCATED WITHIN RESIDENCE SECTION J, MARCOS HIGHWAY, BAGUIO CITY, AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1	SECTION 1. A parcel of land located within Residence Section J along
2	Marcos Highway, Baguio City is hereby excluded from the Baguio Townsite
3	Reservation. The said parcel of land is more particularly described as follows:
4	Bounded on the N.E., along lines 1-2-3, by public land, on the S.E.,
5	along line 3-4, by public land, on the S.W., along line 4-5, by public land, on
6	the N.W., along line 5-1 by Marcos Highway.
7	Beginning at a point marked "1" on plan being N. 56°17' W., 1,214.89
8	meters from triangulation "Bakakeng," Baguio Townsite;
