AN ACT CONVERTING THE CAMARINES SUR STATE AGRICULTURAL COLLEGE IN THE MUNICIPALITY OF PILI, PROVINCE OF CAMARINES SUR INTO A STATE UNIVERSITY KNOWN AS THE CENTRAL BICOL STATE TO BE UNIVERSITY OF AGRICULTURE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Conversion. - The Camarines Sur State Agricultural 1 College in the Municipality of Pili, Province of Camarines Sur is hereby 2 converted into a state university to be known as the Central Bicol State 3 University of Agriculture, hereinafter referred to as the University. 4

SEC. 2. General Mandate. - The University shall primarily provide 5 both advanced instruction and research in agriculture and allied technological 6 sciences including education, arts and related sciences. It shall also undertake 7 extension and development programs, and provide the necessary instructional 8 and research leadership in agricultural, environmental and technological 9 development in the Bicol Region. 10

Offerings. - The University shall offer 1 SEC. 3. Curricular 2 undergraduate and graduate courses in the fields of agriculture, environmental 3 management, engineering, education, arts and sciences and other degree 4 courses within its areas of specialization and according to its capabilities, as the Board of Regents may deem necessary to carry out its objectives and in 5 6 order to meet the needs of the Province of Camarines Sur and the Bicol 7 Region.

8 The existing high school shall be transferred to the jurisdiction and 9 supervision of the Department of Education (DepEd): *Provided*, That the high 10 school shall be allowed to remain and operate within the campus of the 11 University until the existing students shall have completed their high school 12 education: *Provided, further*, That the University may operate a reasonably-13 sized laboratory school, if it has a College of Education.

14 SEC. 4. Administration. – The University shall have the general powers 15 of a corporation set forth in Batas Pambansa Blg. 68, as amended, otherwise 16 known as the "Corporation Code of the Philippines". The administration of the 17 University and the exercise of its corporate powers shall be vested exclusively 18 in the Board of Regents and the president of the University.

- SEC. 5. The Governing Board. The governing board of the
 University shall be the Board of Regents, hereinafter referred to as the Board,
 which shall be composed of the following:
- (a) The chairperson of the Commission on Higher Education (CHED),
 chairperson;

(b) The president of the University, vice chairperson;

25 (c) The chairperson of the Committee on Education, Arts and Culture26 of the Senate, member;

27 (d) The chairperson of the Committee on Higher and Technical28 Education of the House of Representatives, member;

- 1 (e) The regional director of the National Economic and Development 2 Authority (NEDA), member;
- 3 (f) The regional director of the Department of Agriculture (DA), 4 ' member;
- 5

(g) The president of the faculty association of the University, member;

- 6
- (h) The president of the student council of the University, member;
- 7 (i) The president of the alumni association of the University, member;8 and
- 9 (j) Two prominent citizens from the private sector who have 10 distinguished themselves in their profession or fields of specialization of the 11 University, members.
- The Board shall appoint the two prominent citizens from among a list of at least five persons qualified in the Province of Camarines Sur, as recommended by the search committee constituted by the University president, in consultation with the chairperson of the CHED and other members of the Board, based on the normal standards and qualifications for the position.
- 17 The term of office of the president of the faculty association, the 18 president of the student council and the president of the alumni association 19 shall be coterminous with their respective terms of office, as set forth in their 20 respective constitutions and bylaws.
- The two prominent citizens shall serve for a term of two years from thedate of appointment.
- SEC. 6. *Promulgation and Implementation of Policies.* The Board shall promulgate and implement policies in accordance with the declared State policies on education and other pertinent provisions of the Philippine Constitution on education, agriculture, science and technology, as well as the policies, standards and thrusts of the CHED under Republic Act No. 7722, otherwise known as the "Higher Education Act of 1994".

1 SEC. 7. Powers and Duties of the Board of Regents – The Board shall 2 have the following specific powers and duties in addition to its general powers of administration and the exercise of all the powers granted to the board of 3 directors of a corporation under existing laws: 4

5 (a) To promulgate rules and regulations as may be necessary to carry out the purposes and functions of the University; 6

7 (b) To receive and appropriate all sums as may be provided for the 8 support of the University in the manner it may determine in its discretion, in order to carry out the purposes and functions of the University; 9

10 (c) To import duty-free economic, technical and cultural books and/or 11 publications, upon certification by the CHED that such imported books and/or 12 publications are for economic, technical, vocational, scientific, philosophical, 13 historical or cultural purposes in accordance with the provisions of the Tariff and Customs Code, as amended; 14

(d) To receive in trust legacies, gifts and donations of real and personal 15 properties of all kinds and to administer and dispose of the same when 16 necessary for the benefit of the University, and subject to the limitations, 17 18 directions and instructions of the donor, if any.

Such donations shall be exempt from the donor's tax and the same shall 19 be considered as allowable deductions from the gross income in the 20 21 computation of the income tax of the donor, in accordance with the provisions of the National Internal Revenue Code (NIRC), as amended: Provided, That 22 such donations shall not be disposed of, transferred or sold; 23

24 (e) To fix the tuition fees and other necessary school charges, such as, 25 but not limited to, matriculation fees, graduation fees and laboratory fees, as the Board may deem proper to impose, after due consultations with the 26 27 involved sectors.

Such fees and charges, including government subsidies and other 1 2 income generated by the University, shall constitute special trust funds and 3 shall be deposited in any authorized government depository bank, and all interests that shall accrue therefrom shall form part of the same funds for the 4 use of the University. 5

Any provision of existing laws, rules and regulations to the contrary 6 notwithstanding, any income generated by the University from tuition fees and 7 other charges, as well as from the operation of auxiliary services and land 8 grants, shall be retained by the University, and may be disbursed by the Board 9 for instruction, research, extension or other programs/projects of the 10 University: Provided, That all fiduciary fees shall be disbursed for the specific 11 purposes for which they are collected. 12

If, for reasons beyond its control, the University shall not be able to 13 pursue any project for which the funds have been appropriated and allocated 14 under its approved program of expenditures, the Board may authorize the use 15 of said funds for any reasonable purpose which, in its discretion, may be 16 17 necessary and urgent for the attainment of the objectives and goals of the 18 University;

19 (f) To adopt and implement a socialized scheme of tuition and school fees for greater access to poor but deserving students; 20

21 (g) To authorize the construction or repair of its buildings, machinery, 22 equipment and other facilities, and the purchase and acquisition of real 23 property, including necessary supplies, materials and equipment;

(h) To appoint upon recommendation of the president of the 25 University, vice presidents, deans, directors, heads of campuses, faculty

officials and employees, subject to the provisions of the Revised Compensation

26 members and other officials and employees of the University; (i) To fix and adjust salaries of faculty members and administrative 27

and Position Classification System and other pertinent budget and compensation laws governing hours of service and such other duties and conditions as it may deem proper; to grant them, at its discretion, leaves of absence under such regulations as it may promulgate, any provision of existing law to the contrary notwithstanding; and to remove them for cause in accordance with the requirements of due process of law;

7 8 (j) To approve the curricula, instructional programs and rules of discipline drawn by the administrative and academic councils herein provided;

(k) To set policies on admission and graduation of students;

10 (1) To award honorary degrees upon persons in recognition of their 11 outstanding contribution in the fields of education, public service, arts, science 12. and technology, agriculture or in any field of specialization within the 13 academic competence of the University; and to authorize the awarding of 14 certificates of completion of nondegree and nontraditional courses;

(m) To establish and absorb nonchartered tertiary institutions within the Province of Camarines Sur as branches and centers in coordination with the CHED, and in consultation with the Department of Budget and Management (DBM), and to offer therein programs or courses, to promote and carry out equal access to educational opportunities as mandated by the Constitution;

20 (n) To establish research and extension centers of the University where21 such will promote the development of the latter;

22 (o) To establish chairs in the University and to provide fellowships for23 qualified faculty members and scholarships to deserving students;

(p) To delegate any of its powers and duties provided hereinabove to
the president and/or other officials of the University as it may deem
appropriate, so as to expedite the administration of the affairs of the
University;

(a) To authorize an external management audit of the University, to be 1 2 financed by the CHED, subject to Commission on Audit rules and regulations; 3 and to institute reforms, including academic and structural changes, on the basis of the audit results and recommendations: 4

(r) To collaborate with other governing boards of the state colleges and universities within the Province of Camarines Sur or the Bicol Region, under 6 the supervision of the CHED and in consultation with the DBM, and work 7 towards the restructuring of the University to become more efficient, relevant, 8 productive and competitive; 9

(s) To enter into joint ventures with business and industry for the 10 profitable development and management of the economic assets of the 11 University, the proceeds from which shall be used for the development and 12 13 strengthening of the University;

14 -(t) To develop consortia and other economic forms of linkages with local government units, institutions and agencies, both public and private. local 15 and foreign, in the furtherance of the purpose and objectives of the University; 16

(u) To develop academic arrangements for institutional capability 17 18 building with appropriate institutions and agencies, public and private, local 19 and foreign, and to appoint experts/specialists as consultants, part-time or visiting or exchange professors, scholars or researchers, as the case may be; 20

(v) To set up the adoption of modern and innovative modes of 21 22 transmitting knowledge such as the use of information technology, the dual system, open learning or distance education and community laboratory for the 23 24 promotion of greater access to education;

(w) To establish policy guidelines and procedures for participative 25 26 decision-making and transparency within the University;

(x) To privatize, where most advantageous to the University,
 management of nonacademic services such as health, food, building or grounds
 or property maintenance and such other similar activities; and

.

4 (y) To extend the term of the president of the University beyond the 5 age of retirement but not beyond the age of seventy (70), whose performance 6 has been unanimously rated by the governing board as outstanding based on 7 the guidelines, qualifications and/or standards set by the Board, after 8 unanimous recommendation by the search committee.

9. SEC. 8. Meetings of the Board. – The Board shall regularly convene at
10 least once every quarter. However, the chairperson of the Board may, upon
11 three days' prior written notice, call a maximum of two specials meetings
12 whenever necessary.

13 A quorum of the Board shall consist of majority of all its members 14 holding office at the time of the meeting: *Provided*, *however*, That the 15 chairperson of the Board or the president of the University is among those 16 present in the meeting.

17 In the absence of the chairperson of the CHED, a commissioner of the CHED, duly designated by him/her, shall represent him/her in the meeting with 18 all the rights and responsibilities of a regular member: Provided, however, 19 That during this meeting, the president of the University as vice chairperson 20 shall be the presiding officer: Provided, further, That this proviso 21 notwithstanding, the chairperson of the CHED is hereby authorized to 22 23 designate a CHED commissioner as the regular chair of the Board, in which 24 case said CHED commissioner shall act as the presiding officer.

In case the chairpersons of the Congressional Committees on Education shall not be able to attend the board meeting, they may duly designate their respective representatives to attend the said meeting, who shall have the same rights and responsibilities as a regular member of the Board. 1 The members of the Board shall not receive any salary but shall be 2 entitled to reimbursements for actual and necessary expenses incurred, either in 3 their attendance to meetings of the Board or in connection with other official 4 business authorized by resolution of the Board, subject to existing laws and 5 regulations.

6 SEC. 9. The University President. - The University shall be headed by 7 a president, who shall render full time service. He/she shall be appointed by 8 the Board, subject to the guidelines, gualifications and/or standards set by the 9 Board, upon recommendation of a duly constituted search committee. He/she shall serve for a term of four years and shall be eligible for reappointment for 10 another term: *Provided*. That in order to effect a smooth transition to a state 11 12 university, the incumbent president of the Camarines Sur State Agricultural 13 College shall ipso facto become the first president of the University.

Within six months before the expiration of the term of office of the
incumbent president of the Central Bicol State University of Agriculture, the
Board shall constitute the Search Committee for the Presidency (SCP).

17 In case of vacancy in the office of the president by reason of death, 18 compulsory retirement, resignation, removal for cause or incapacity of the 19 president to perform the functions of his/her office, the Board shall have the 20 authority to designate an officer-in-charge of the University pending the 21 appointment of a new president.

In case of vacancy in the office of the president as mentioned in the
immediately preceding paragraph, his/her successor or the officer-in-charge
shall hold office for the unexpired term only.

The powers and duties of the president of the University, in addition to those specifically provided in this Act, shall be those usually pertaining to the office of the president of similar universities, and those delegated by the Board. 1 The salary of the president of the University shall be in accordance with 2 the Revised Compensation and Position Classification System and shall be 3 comparable to that being received by the presidents of similar educational 4 institutions.

5 The president of the University shall be assisted by a vice president for 6 academic affairs and a vice president for administration who shall be appointed 7 by the Board upon recommendation of the president.

8 SEC. 10. *The Administrative Council.* – There shall be an 9 administrative council consisting of the president of the University as 10 chairperson, vice presidents, deans, directors and other officials of equal rank 11 as members, whose duty is to review and recommend to the Board the policies 12 governing the administration, management and development planning of the 13 University.

SEC. 11. *The Academic Council.* – There shall be an academic council
with the president of the University as chairperson and all members of the
academic staff with the rank of not lower than assistant professor as members.

17 The Academic Council shall have the power to review and recommend 18 the curricular offerings and rules of discipline of the University, subject to the 19 approval of the Board. It shall fix the requirements for the admission of 20 students, as well as for their graduation and the conferment of degrees, subject to review and/or approval by the Board through the president of the University. 21 22 It shall have the disciplinary power over students of the University and shall formulate academic policies and rules and regulations on discipline, subject to 23 24 the approval of the Board.

SEC. 12. The Secretary of the University. – The Board shall appoint a
Secretary, who shall serve as such for both the Board and the University and
shall keep all records and proceedings of the Board. He/she shall serve upon
each member of the Board the appropriate notice of the Board's meetings.

SEC. 13. The Treasurer of the University. – The Treasurer of the
 Philippines shall be the ex officio treasurer of the University.

2

3 SEC. 14. *Faculty.* – No political beliefs, gender preference, cultural or 4 community affiliation or ethnic origin, and religious opinion or affiliation shall 5 be a matter of inquiry in the appointment of faculty members of the University: 6 *Provided, however,* That said appointment shall be subject to the guidelines, 7 qualifications and/or standards set by the Board: *Provided, further,* That no 8 member of the faculty shall teach for or against any particular church or 9 religious sect.

SEC. 15. Scholarship Program/Admission... – The University shall
 provide a scholarship program and other affirmative action programs to assist
 poor but deserving students who qualify for admission to the University.

No student shall be denied admission to the University by reason of sex,
religion, cultural or community affiliation or ethnic origin.

SEC. 16. Academic Freedom and Institutional Autonomy. – The
University shall enjoy academic freedom and institutional autonomy, pursuant
to Paragraph 2, Section 5 of Article XIV of the Constitution of the Republic of
the Philippines.

19 SEC. 17. Authority to Loan or Transfer Apparatus/Equipment/Supplies and Detail of Personnel. - The heads of the bureaus and offices of the national 20 government are hereby authorized to loan or transfer, upon the request of the 21 president of the University, such apparatus, equipment or supplies as may be 22 23 needed by the University, and to detail employees for duty therein when, in the judgment of the head of bureau or office, such apparatus, equipment, 24 supplies or services of such employees can be spared without serious detriment 25 26 to the public service.

1 The employees so detailed shall perform such duties as required of them 2 by the president of the University, and the time so employed shall be counted 3 as part of their regular services.

4

4 SEC. 18. Assets, Liabilities and Personnel. – All assets, real and 5 personal, personnel and records of the Camarines Sur State Agricultural 6 College, as well as liabilities or obligations, are hereby transferred to the 7 University. The positions, rights and security of tenure of faculty members and 8 personnel therein employed under existing laws prior to the conversion into a 9 University shall be respected.

10 All parcels of land belonging to the government occupied by the 11 Camarines Sur State Agricultural College are hereby declared to be property of 12 the Central Bicol State University of Agriculture and shall be titled under that 13 name: *Provided*, That should the University cease to exist or be abolished or 14 should such parcels of land aforementioned be no longer needed by the 15 University, the same shall revert to the national government.

16 SEC. 19.' *Appropriations.* – The amount necessary to carry out the 17 provisions of this Act shall be charged against the current year's appropriations 18 of the Camarines Sur State Agricultural College, except the sums needed to 19 continue the operations of the existing high school. Thereafter, such sums as 20 may be necessary for the continued operation and maintenance of the Central 21 Bicol State University of Agriculture shall be included in the annual General 22 Appropriations Act.

SEC. 20. Development Plan, Management Audit, Organizational/
 Administrative/Academic Structure. - Within the period of one hundred twenty
 (120) days after the approval of this Act, the University shall accomplish the
 following:

(a) Submit a five-year development plan, including its correspondingprogram budget to the CHED, for corresponding recommendation to the DBM;

(b) Undergo a management audit in cooperation with the CHED; and

2 (c) Accordingly set up its organizational, administrative as well as
 3 academic structure, including the appointment of the University key officials.

SEC. 21. *Filing of Report.* – On or before the fifteenth (15th) day of the second month after the opening of the regular classes each year, the Board shall file with the Office of the President of the Philippines through the chairperson of the CHED, and with both Houses of Congress a detailed report on the progress, conditions and needs of the University.

9 SEC. 22 Suppletory Application. -- The provisions of Republic Act 10 No. 8292, otherwise known as the "Higher Education Modernization Act of 11 1997", shall be an integral part of this Act and shall serve as part of the 12 governing charter of the University.

SEC. 23. Parity Clause. – All other powers, functions and privileges,
 responsibilities and limitations to state universities and/or their officials under
 existing laws shall be deemed granted to or imposed upon the University
 and/or its officials whenever appropriate.

SEC. 24. Implementing Rules and Regulations. - The Board, in
consultation with the CHED, shall formulate the guidelines to fully implement
the provisions of this Act.

SEC. 25. Separability Clause. - If, for any reason, any part or provision
 of this Act is declared invalid or unconstitutional, the remaining parts or
 provisions not affected shall remain in full force and effect.

SEC. 26. *Repealing Clause.* – All laws, presidential decrees, executive
 orders, rules and regulations contrary to or inconsistent with the provisions of
 this Act are hereby repealed or modified accordingly.

SEC. 27. *Effectivity.* – This Act shall take effect fifteen (15) days after
its publication in two newspapers of general circulation.
