AN ACT TO ESTABLISH A LITTLE LEAGUE BASEBALL PARK WHICH SHALL SERVE AS THE VENUE FOR THE TRAINING AND HOLDING OF COMPETITIONS FOR YOUNG BASEBALL PLAYERS IN THE PROVINCE OF CAMARINES SUR, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There is hereby authorized to be established a Little
2 League Baseball Park in the Province of Camarines Sur which shall serve as
3 the venue for the training and holding of competitions for young baseball
4 players. Said baseball park shall have two diamond grounds adequate for the
5 holding of simultaneous games and shall be constructed in accordance with
6 specifications and dimensions based on internationally accepted standards and
7 measurements for Little League Baseball.

1 SEC. 2. In order to provide for a reasonably adequate space for the
2 construction of the playing fields, bleachers, showers and the administrative
3 office and parking spaces, the Little League Baseball Park shall be provided
4 with at least *One hectare land for its facilities and services* as the governor of
5 the province shall provide with the approval or concurrence of the
6 Sangguniang Paarlalawigan of the Province of Camarines Sur.

7 SEC. 3. For purposes of implementing the intentions of this Act, the
8 provincial government of Camarines Sur shall provide:

9 (a) The land required or the requisite appropriation for the acquisition
10 of the land in a suitable location within the province.

11 (b) The sum of One million pesos (P1,000,000.00) shall be provided
12 for the construction of the baseball diamonds in the playing fields (including
13 the *leveling of land according to the desired specifications*), and as necessary,
14 the landscaping of the appropriate spaces within the park. *Said sums shall be*
15 *made chargeable to the funds authorized under local appropriation ordinance*
16 *of the provincial government of Camarines Sur.*

17 (c) The *additional sum of at least One hundred thousand pesos*
18 *(P100,000.00) as may be appropriated by the provincial government of*
19 *Camarines Sur for the purchase of baseball equipment and other supportive*
20 *paraphernalia and for the acquisition of uniforms and other training and*
21 *competition attire for the young baseball players selected to train in the park.*

1 In reciprocation to the financial commitments of the provincial
2 government of Camarines Sur stipulated in this Act, the national government
3 directly or through the Philippine Sports Commission shall include in their
4 appropriation such sums as may be necessary for the construction of the
5 bleachers, showers, comfort rooms and the administrative office of the Little
6 League Baseball Park.

7 Any other balance of the financial requirements to make the Little
8 League Baseball Park operational and to maintain the park in an economically
9 viable manner shall be the responsibility of the respective local government
10 unit wherein the park is constructed, which additional funding shall be charged
11 to its municipal funds and/or obtained from grants or donations that it may
12 arrange or obtain from private philanthropic sources.

13 SEC. 4. This Act shall take immediate effect upon its approval.
