AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY MANGMANGA IN THE MUNICIPALITY OF SAN EMILIO, PROVINCE OF ILOCOS SUR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. Creation of Barangay Mangmanga. The Sitio of
  Mangmanga is hereby separated from Barangay San Miliano and constituted
  into a new barangay to be known as Barangay Mangmanga in the Municipality
  of San Emilio, Province of Ilocos Sur.

- 4 SEC. 3. Barangay Officials. The first set of officials of the said
- 5 barangay shall be appointed by the President of the Republic of the Philippines
- 6 and shall hold office until such time that their successors have been duly
- 7 elected and qualified.
- 8 SEC. 4. Public Infrastructure and Facilities All existing public
- 9 infrastructure and facilities for public use existing therein at the time of the
- 10 approval of this Act are hereby transferred without cost or compensation to and
- shall be administered by the new barangay.
- 12 SEC. 5. Internal Revenue Allotment Shares. Barangay Mangmanga
- shall be entitled to Internal Revenue Allotment shares pursuant to Section 285
- of Republic Act No. 7160, otherwise known as the Local Government Code of
- 15 1991.
- 16 SEC. 6. Appropriations. The amount necessary to conduct the
- 17 plebiscite as provided for under this Act shall be borne by the Municipality of
- 18 San Emilio, Province of Ilocos Sur.
- 19 SEC. 7. Effectivity. This Act shall take effect upon its approval.
