AN ACT SEPARATING THE SITIOS OF ILEB, NEW COLAYO VILLAGE, KINAMA AND NAMBARAN DAYA FROM BARANGAY NAMBARAN, CITY OF TABUK, PROVINCE OF KALINGA AND CONSTITUTING THEM INTO A SEPARATE AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY NAMBARAN EAST

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Creation of Barangay Nambaran East.* – The
2 sitios of Ileb, New Colayo Village, Kinama and Nambaran Daya are
3 hereby separated from Barangay Nambaran in the City of Tabuk,
4 Province of Kalinga to constitute a separate and independent
5 barangay to be known as Barangay Nambaran East.

6 SEC. 2. *Territorial Boundaries.* – The territorial boundaries
7 of Barangay Nambaran East shall be described as follows:

8 “Bounded on the East by the Municipality of Rizal; on the
9 South by Barangay Lacnog; on the West by Barangay Nambaran;
10 and on the Northwest by Barangay Dilag.”

1 SEC. 3. *Conduct and Supervision of Plebiscite.* – Pursuant to
2 Section 10 of Republic Act No. 7160, as amended, otherwise known
3 as the “Local Government Code of 1991”, the new Barangay
4 Nambaran East shall exist upon the approval by a majority of the
5 votes cast by the qualified voters of Barangay Nambaran in a
6 plebiscite to be conducted and supervised by the Commission on
7 Elections (COMELEC) in the area affected, not later than one
8 hundred twenty (120) days from the effectivity of this Act.

9 The amount necessary for the conduct of such plebiscite shall
10 be borne by the City of Tabuk, Province of Kalinga.

11 SEC. 4. *Barangay Officials.* – The first set of officials of
12 Barangay Nambaran East shall be appointed by the Provincial
13 Governor and shall hold office until such time that their successors
14 have been duly elected and qualified.

15 SEC. 5. *Public Infrastructure and Facilities.* – All public
16 infrastructure and facilities existing therein at the time of the
17 approval of this Act are hereby transferred without cost or
18 compensation to and shall be administered by the new barangay.

19 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay
20 Nambaran East shall be entitled to Internal Revenue Allotment
21 (IRA) shares pursuant to Section 285 of the Local Government Code
22 of 1991, as amended.

23 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)
24 days after its publication in the *Official Gazette* or in a newspaper of
25 general circulation.
