AN ACT POSTPONING THE MAY 2020 BARANGAY AND SANGGUNIANG KABATAAN ELECTIONS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9164, AS AMENDED BY REPUBLIC ACT NO. 9340, REPUBLIC ACT NO. 10632, REPUBLIC ACT NO. 10656, REPUBLIC ACT NO. 10923 AND REPUBLIC ACT NO. 10952, AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 1 of Republic Act No. 9164, as amended, is hereby further amended to read as follows:

"SECTION 1. Date of Election. - There shall be 3 synchronized barangay and sangguniang kabataan 4 elections, which shall be held on July 15, 2002. 5 Subsequent synchronized barangay and sangguniang 6 kabataan elections shall be held on the last Monday of 7 October 2007 and every three (3) years thereafter: 8 9 Provided. That the barangay and sangguniang kabataan elections on [October 23, 2017] THE SECOND 10 MONDAY OF MAY 2020 shall be postponed to [the 11 second Monday of May 2018 DECEMBER 5, 2022. 12 Subsequent synchronized barangay and sangguniang 13 kabataan elections shall be held on the second Monday 14 of May 2020 FIRST MONDAY OF DECEMBER 2025 and 15 every three (3) years thereafter." 16 17 SEC. 2. Section 4 of Republic Act No. 9164, as amended, is 18 hereby further amended to read as follows:

"SEC. 4. Assumption of Office. – The term of office of the barangay and sangguniang kabataan officials elected under this Act shall commence at noon

of June 30 next following their election: Provided, however, That the term of office of the barangay and sangguniang kabataan officials elected in the [May 2020] DECEMBER 5, 2022 elections and subsequently thereafter, shall commence at noon of [June 30] JANUARY 1 next following their election."

SEC. 3. Hold-Over. — Until their successors shall have been duly elected and qualified, all incumbent barangay and sangguniang kabataan officials shall remain in office, unless sooner removed or suspended for cause: Provided, That barangay and sangguniang kabataan officials who are ex officio members of the sangguniang bayan, sangguniang panlungsod, or sangguniang panlalawigan, as the case may be, shall continue to serve as such members in the sanggunian concerned until the next barangay and sangguniang kabataan elections. The Liga ng mga Barangay and the Pederasyon ng Sangguniang Kabataan at the municipal, city, and provincial levels shall conduct elections for ex officio positions in the sanggunians under the supervision of the Department of the Interior and Local Government.

SEC. 4. Appropriations. — The amount necessary for the implementation of this Act shall be taken from the appropriations of the Commission on Elections (COMELEC) under the General Appropriations Act and/or supplementary appropriations thereafter.

SEC. 5. Repealing Clause. – All other laws, acts, presidential decrees, executive orders, issuances, presidential proclamations, rules and regulations or parts thereof, which are contrary to and inconsistent with any provision of this Act, are hereby repealed, amended or modified accordingly.

SEC. 6. Separability Clause If any portion or provision of
this Act is declared unconstitutional, the remainder of this Act or
any provision not affected thereby shall remain in force and effect.
SEC. 7. Effectivity This Act shall take effect immediately
following the completion of its publication either in the ${\it Official}$
Gazette or in two (2) newspapers of general circulation.
