AN ACT CREATING A BARANGAY TO BE KNOWN AS
BARANGAY TANYAG IN THE CITY OF TAGUIG

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. *Creation of Barangay Tanyag.* – Tanyag Proper
2 in Barangay Bagong Tanyag, City of Taguig is hereby separated
3 from Barangay Bagong Tanyag and constituted into a distinct and
4 independent barangay to be known as Barangay Tanyag.

5 SEC. 2. *Territorial Boundaries.* – The territorial boundaries
6 of Barangay Tanyag are hereby described as follows:

7 “Bounded on the North by Mañalac Avenue;

8 On the East by Manila Railroad Company (Railroad Tract);

9 On the South by Lots 8019, 8018, 8025 Case 15 Mcadm 590-D
10 Taguig Cadastral Mapping; and

11 On the West by North Daang Hari Road and Parañaque
12 Cadastre.”

13 SEC. 3. *Conduct and Supervision of Plebiscite.* – The
14 plebiscite conducted and supervised by the Commission on Elections

1 (COMELEC) in Barangay Bagong Tanyag pursuant to City
2 Ordinance No. 25, Series of 2008 of the Sangguniang Panlungsod of
3 the City of Taguig, which ratified the creation of Barangay Tanyag
4 as proclaimed by the City Board of Canvassers on December 28,
5 2008, shall serve as substantial compliance with the plebiscite
6 requirement under Section 10 of Republic Act No. 7160, as
7 amended, otherwise known as the "Local Government Code of
8 1991".

9 SEC. 4. *Incumbent Barangay Officials.* – The incumbent
10 barangay officials of Barangay Tanyag, City of Taguig shall
11 continue to hold office until such time that their successors have
12 been duly elected and qualified.

13 SEC. 5. *Public Infrastructure and Facilities.* – All public
14 infrastructure and facilities existing therein at the time of the
15 approval of this Act are hereby transferred without cost or
16 compensation to and shall be administered by the new barangay.

17 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay
18 Tanyag shall be entitled to Internal Revenue Allotment (IRA)
19 shares pursuant to Section 285 of the Local Government Code of
20 1991, as amended.

21 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)
22 days after its publication in the *Official Gazette* or in a newspaper
23 of general circulation.
