AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY  
SOUTH DAANG HARI IN THE CITY OF TAGUIG

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1           SECTION 1. *Creation of Barangay South Daang Hari.* –  
2   South Daang Hari Proper in Barangay Bagong Tanyag, City of  
3   Taguig is hereby separated from Barangay Bagong Tanyag and  
4   constituted into a distinct and independent barangay to be known  
5   as Barangay South Daang Hari.

6           SEC. 2. *Territorial Boundaries.* – The territorial boundaries  
7   of Barangay South Daang Hari are hereby described as follows:

8           “Bounded on the North by the property line of Perpetual  
9   Village Phase II;

10          On the East by Manila Railroad Company (Railroad Tract);

11          On the South by Lot – 4547 Psu-13088 (Parañaque Cadastre),  
12   Lot-8042 Case 16 Taguig Cadastral Mapping and the Bagumbayan  
13   River; and

14          On the West by Parañaque Cadastre.”

1           SEC. 3. *Conduct and Supervision of Plebiscite.* – The  
2 plebiscite conducted and supervised by the Commission on Elections  
3 (COMELEC) in Barangay Bagong Tanyag pursuant to City  
4 Ordinance No. 26, Series of 2008 of the Sangguniang Panlungsod of  
5 the City of Taguig, which ratified the creation of Barangay South  
6 Daang Hari as proclaimed by the City Board of Canvassers on  
7 December 28, 2008, shall serve as substantial compliance with the  
8 plebiscite requirement under Section 10 of Republic Act No. 7160,  
9 as amended, otherwise known as the “Local Government Code  
10 of 1991”.

11           SEC. 4. *Incumbent Barangay Officials.* – The incumbent  
12 barangay officials of Barangay South Daang Hari, City of Taguig  
13 shall continue to hold office until such time that their successors  
14 have been duly elected and qualified.

15           SEC. 5. *Public Infrastructure and Facilities.* – All  
16 infrastructure and facilities for public use existing therein at the  
17 time of the approval of this Act are hereby transferred without cost  
18 or compensation to and shall be administered by the new barangay.

19           SEC. 6. *Internal Revenue Allotment Shares.* – Barangay  
20 South Daang Hari shall be entitled to Internal Revenue Allotment  
21 (IRA) shares pursuant to Section 285 of the Local Government Code  
22 of 1991, as amended.

23           SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)  
24 days after its publication in the *Official Gazette* or in a newspaper of  
25 general circulation.
