AN ACT SEPARATING THE SITIO OF LADOL FROM BARANGAY POBLACION IN THE MUNICIPALITY OF ALABEL, PROVINCE OF SARANGANI AND CONSTITUTING IT INTO A DISTINCT AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY LADOL

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. *Creation of Barangay Ladol.* – The sitio of Ladol is  
2 hereby separated from Barangay Poblacion in the Municipality of  
3 Alabel, Province of Sarangani to constitute into a distinct and  
4 independent barangay to be known as Barangay Ladol.

5           SEC. 2. *Territorial Boundaries.* – The territorial boundaries  
6 of Barangay Ladol are hereby described as follows:

15           SEC. 3. *Conduct and Supervision of Plebiscite.* – The  
16 plebiscite conducted and supervised by the Commission on Elections  
17 (COMELEC) pursuant to Provincial Ordinance No. 2011-7-048,  
18 Series of 2011 of the Sangguniang Panlalawigan of the Province of  
19 Sarangani, which ratified the creation of Barangay Ladol as  
20 proclaimed by the Plebiscite Board of Canvassers on August 18,  
21 2012, shall serve as substantial compliance with the plebiscite  
22 requirement under Section 10 of Republic Act No. 7160, as  
23 amended, otherwise known as the “Local Government Code of  
24 1991”.

25           SEC. 4. *Incumbent Barangay Officials.* – The incumbent  
26 elected barangay officials of Barangay Ladol shall continue to hold  
27 office until such time that their successors have been duly elected  
28 and qualified.

1           SEC. 5. *Public Infrastructure and Facilities.* – All public  
2 infrastructure and facilities existing therein at the time of the  
3 approval of this Act are hereby transferred without cost or  
4 compensation to and shall be administered by the new Barangay  
5 Ladol.

6           SEC. 6. *Internal Revenue Allotment Shares.* – Barangay  
7 Ladol shall be entitled to Internal Revenue Allotment (IRA) shares  
8 pursuant to Section 285 of the Local Government Code of 1991, as  
9 amended.

10          SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)  
11 days after its publication in the *Official Gazette* or in a newspaper of  
12 general circulation.
