BY REPRESENTATIVE PIMENTEL, PER COMMITTEE REPORT NO. 85

AN ACT CREATING A BARANGAY TO BE KNOWN AS
BARANGAY GUINHALINAN IN THE MUNICIPALITY OF
BAROBO, PROVINCE OF SURIGAO DEL SUR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. *Creation of Barangay Guinhalinan.* – There is
2 hereby created a barangay to be known as Barangay Guinhalinan in
3 the Municipality of Barobo, Province of Surigao del Sur.

4 SEC. 2. *Territorial Boundaries.* – The territorial boundaries
5 of Barangay Guinhalinan shall be described as follows:

6 "Bounded on the North by Barangay Javier, Barobo, Surigao
7 del Sur: Pls-44 Survey: Lot Nos. 2153, 2154, 2157, 2158, 2528, 2161,
8 2162, 2296, 2166, 2169, 2170, 2106, 2174, 2177, 3329, 2178, 2181,
9 2182, 2185, 2186, 2189, 2190, 2193, 2552 or CAD-949-D Survey: Lot
10 Nos. 8892, 8897, 8898, 8907, 8912, 8917, 8920 part, 8921, 8961,
11 8940, 8946, 8952, 8960, 8965, 8970, 8978 part, 8028 part, 8018,
12 8019, 8020, 8002, 8004, 8005, 7750, 7755;

13 "On the East by Barangay Batunan, Tagbina, Surigao del Sur;

1 “On the West by Barangay Javier, Barobo, Surigao del Sur:
2 Pls-44 Survey: Lot Nos. 2151, 2126, including homestead road
3 adjacent to said lots or CAD-949-D Survey: Lot Nos. 8885, 8856,
4 8838, 8837, 8833, 8776, CSD-13-004043-D Survey: Lot Nos. 49, 51
5 part, 52 part, 56 part, 61 part, 63 part; Timberland: Straightline
6 from West of Lot Nos. 2152, 2243, all of Pls-44 up to Binooyan
7 Creek, traverse along the Binooyan Creek (crossing on the left side),
8 up to boundary of the Province of Agusan del Sur;

9 “On the South by the Province of Agusan del Sur.”

10 The entire territorial jurisdiction of Barangay Guinhalinan
11 shall contain an approximate land area of more or less two
12 thousand three hundred seventy hectares (2,370 has.).

13 SEC. 3. *Conduct and Supervision of Plebiscite.* – The
14 plebiscite conducted and supervised by the Commission on Elections
15 (COMELEC) pursuant to Sangguniang Panlalawigan ng Surigao
16 Provincial Resolution No. 79 - 16, which was duly ratified and
17 proclaimed by the Plebiscite Board of Canvassers on August 1, 1979,
18 shall serve as substantial compliance with the plebiscite
19 requirement under Section 10 of Republic Act No. 7160,
20 as amended, otherwise known as the “Local Government Code
21 of 1991”.

22 SEC. 4. *Incumbent Barangay Officials.* – The incumbent
23 elected barangay officials of Barangay Guinhalinan shall continue
24 to hold office until such time that their successors have been duly
25 elected and qualified.

26 SEC. 5. *Public Infrastructure and Facilities.* – All public
27 infrastructure and facilities existing therein at the time of the
28 approval of this Act are hereby transferred without cost or
29 compensation to and shall be administered by the new barangay.

1 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay
2 Guinhalinan shall be entitled to Internal Revenue Allotment (IRA)
3 shares pursuant to Section 285 of the Local Government Code of
4 1991, as amended.

5 SEC. 7. *Repealing Clause.* – All laws, decrees, executive
6 orders, rules and regulations which are inconsistent with this Act
7 are hereby amended, repealed or modified accordingly.

8 SEC. 8. *Effectivity.* – This Act shall take effect fifteen (15)
9 days after its publication in the *Official Gazette* or in a newspaper
10 of general circulation.
