"AN ACT

RECLASSIFYING AS AGRICULTURAL LAND A PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED AT LOURDES, ALUBIJID, PROVINCE OF MISAMIS ORIENTAL, TO BE UTILIZED AS THE SITE OF THE SCIENCE AND TECHNOLOGY PARK OF THE UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. Declaration as Agricultural Land. - A parcel of land of 1 the public domain classified as timberland under Land Classification Map No. 2 2768 certified and approved on November 20, 1972, and embraced in 3 Presidential Proclamation No. 739, dated November 26, 2004, located 4 in Barangay Lourdes, Municipality of Alubijid, Province of Misamis Oriental, is 5 hereby reclassified as agricultural land and shall be utilized as the site of the 6 Science and Technology Park of the University of Science and Technology of 7 Southern Philippines. 8

9 The said parcel is more particularly described as Lot 3, NR-10-000011 10 AMD. pertaining to the area beginning at a point marked "1" on plan, being S 11 82° 45' W, 2,720.24 meters from BLLM No.1, GSS-580 with geographic 12 coordinates of 08° 31' 29.210" Latitude and 124° 26' 00.775 Longitude located at 13 Barangay Lourdes, Alubijid, Province of Misamis Oriental,

SEC. 2. Implementing Rules and Regulations. – Within ninety (90) days from the effectivity of this Act, the Secretary of the Department of Environment and Natural Resources shall issue the corresponding implementing rules and regulations for the effective implementation of this Act.

25 SEC. 3. Separability Clause. – If any provision of this Act is declared 26 unconstitutional or invalid, other parts or provisions hereof not affected shall 27 continue to be in full force and effect.

28 SEC. 4. Repealing Clause. – All laws, presidential decrees, executive 29 orders and regulations or parts thereof inconsistent with the provisions of this 30 Act are hereby repealed, amended or modified accordingly.

SEC. 5. *Effectivity*. – This Act shall take effect fifteen (15) days after its
publication in the *Official Gazette* or in a newspaper of general circulation.
