42 Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

45 Section 1. Appropriations of Fund. The following sums, or so much thereof as may be necessary, are hereby appropriated out of any
46 funds in the National Treasury of the Philippines not otherwise appropriated, for the operation of the Government of the Republic of the
47 Philippines from January one to December thirty-one, two thousand and twenty-two, except where otherwise specifically provided herein:
