AN ACT DECLARING THE SINKING BELL TOWER LOCATED IN THE CITY OF LAOAG, PROVINCE OF ILOCOS NORTE, A TOURISM DESTINATION, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION I. The Sinking Bell Tower located in the City of Laoag, Province of Ilocos
- 2 Norte, is hereby declared a tourism destination. As such, the protection and preservation of the
- 3 Sinking Bell Tower, as well as the development of the area surrounding it, shall be prioritized by
- 4 the Department of Tourism, subject to the rules and regulations governing the development of
- 5 tourism destinations.
- 6 SEC. 2. Within one (1) year after the approval of this Act, the DOT shall, in coordination
- 7 with the Department of Public Works and Highways, the National Historical Commission of the
- 8 Philippines (NHCP), the city government of Laoag, and concerned agencies of the government

- and stakeholders, prepare a tourism development plan that shall include the construction,
- 2 installation and maintenance of such appropriate facilities and infrastructure to enhance tourism in
- 3 the area: Provided, That said development plan shall ensure the preservation of the historical and
- 4 cultural significance of the Sinking Bell Tower: Provided, further, That any intervention work,
- 5 activity and development to be carried out in the area shall conform with the provisions of Republic
- 6 Act No. 10066, otherwise known as the "National Cultural Heritage Act of 2009"
- 7 SEC. 3. The DOT shall take immediate steps to implement the tourism development plan
- 8 and shall incorporate the same in its overall tourism program for the calendar year immediately
- 9 succeeding the approval of this Act. It shall also include the Sinking Bell Tower in all its national,
- 10 regional and local promotion programs.
- 11 SEC 4 The Secretary of DOT and Chairman of the NHCP shall include in their respective
- 12 programs the implementation of this Act, the funding of which shall be included in the annual
- 13 General Appropriations Act, and shall augment such allocation with internally generated funds of
- 14 DOT.
- 15 SEC. 5. Within sixty (60) days from the effectivity of this Act, the DOT shall, in
- 16 consultation with the NHCP, the city government of Laoag, and concerned government agencies
- 17 and stakeholders, promulgate the necessary rules and regulations for the proper implementation of
- 18 this Act.
- 19 SEC. 6. All laws, rules, regulations, presidential decrees and other issuances inconsistent
- 20 with any of the provisions of this Act are hereby deemed repealed or amended accordingly.
- 21 SEC. 7. This Act shall take effect fifteen (15) days after its publication in the Official
- 22 Gazette or in a newspaper of general circulation.
