AN ACT

ESTABLISHING A SEVENTY-FIVE (75) BED GENERAL HOSPITAL TO BE KNOWN AS THE TEODORO N. PEPITO MEMORIAL GENERAL HOSPITAL (TNPMGH) IN THE CITY OF VALENCIA, PROVINCE OF BUKIDNON AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. There shall be established a general hospital in the City of Valencia,
 Province of Bukidnon to be known as the Teodoro N. Pepito Memorial General Hospital
 (TNPMGH).
- 5 SEC. 2. The City Government of Valencia shall manage the TNPMGH, and shall prepare 6 a hospital development plan, aligned with the Philippine Health Facility Development Plan, in 7 consultation with the Department of Health (DOH). The increase in bed capacity, healthcare 8 facilities and service capability shall be based on the hospital development plan.

1 SEC. 3. The City Government of Valencia shall provide the necessary funds for the 2 establishment of TNPMGH. The Secretary of the DOH shall include in the Department's subsidy 3 program, support for the capital outlay requirements of the said hospital.

- SEC. 4. All laws, executive orders, issuances, rules and regulations, inconsistent
 with this Act are hereby modified accordingly.
- SEC. 5. This Act shall take effect fifteen (15) days after its publication in the Official
 Gazette or in a newspaper of general circulation.
