AN ACT
ESTABLISHING A CAMPUS OF THE MINDANAO STATE UNIVERSITY IN THE
MUNICIPALITY OF MUNAI, PROVINCE OF LANA DEL NORTE, TO BE KNOWN
AS THE "MINDANAO STATE UNIVERSITY-MUNAI CAMPUS", AND
APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** This Act shall be known as the "*Mindanao State University-Munai*
2 *Campus Act*".
3

4 **SEC. 2.** There is hereby established a campus of the Mindanao State University (MSU)
5 in the Municipality of Munai, Province of Lanao Del Norte, to be known as the Mindanao
6 State University-Munai Campus.
7

8 **SEC. 3.** The MSU-Munai Campus shall primarily provide short-term, technical-
9 vocational, undergraduate, and graduate courses within its areas of competency and
10 specialization, as the Board of Regents, hereinafter referred to as the Board, may deem
11 necessary for the accomplishment of its objectives, and those which respond to the human
12 resource development needs of the Province of Lanao Del Norte and Region X. The MSU-
13 Munai Campus is also mandated to undertake research and extension services and to provide
14 progressive leadership in these areas.
15

16 The existing reasonably-sized laboratory high school shall continue to operate under the
17 supervision of the College of Education to serve the in-campus requirements of its students.
18

19 **SEC. 4.** The MSU-Munai Campus shall be headed by a Campus Administrator who
20 shall render full-time service and shall be appointed by the Board, subject to qualifications

1 standards prescribed by the Board, and based on the recommendation of the search committee
2 duly constituted for the purpose of selecting the Campus Administrator.
3

4 **SEC. 5.** The MSU-Munai Campus shall comply with the minimum requirements for its
5 operation and program offerings, as prescribed by the Commission on Higher Education.
6

7 **SEC. 6.** All assets, both real and personal, personnel, and records of the MSU-Munai
8 Campus, as well as its liabilities or obligations, shall be titled under or named after the MSU.
9

10 All parcels of land belonging to the government to be occupied by the MSU-Munai
11 Campus shall be the property of the MSU, and shall be titled under its name: *Provided*, That
12 should the campus cease to exist or be abolished or should such aforementioned parcels of
13 land be no longer needed by the MSU, the same shall revert to the concerned local
14 government unit or to the Republic of the Philippines, as the case may be.
15

16 **SEC. 7.** The provisions of Republic Act No. 8292, otherwise known as the “Higher
17 Education Modernization Act of 1997”, shall form part of this Act.
18

19 **SEC. 8.** The amount necessary for the implementation of this Act shall be included in
20 the annual General Appropriations Act.
21

22 **SEC. 9.** If, for any reason, any part or provision of this Act is declared invalid or
23 unconstitutional, the remaining parts or provisions not affected shall remain in full force and
24 effect.

26 **SEC. 10.** All other laws, presidential decrees, executive orders, rules and regulations
27 contrary to or inconsistent with the provisions of this Act are repealed or modified
28 accordingly.

30 **SEC. 11.** This Act shall take effect fifteen (15) days after its publication in the *Official*
31 *Gazette* or in a newspaper of general circulation.
